Naturally-Occurring and Accelerator-Produced Radioactive Materials; Petition for Rulemaking; Notice of Docketing and Request for Comment; Part 30 of Title 10 of the Code of Federal Regulations (10 CFR) (Petition for Rulemaking (PRM) 30-66; NRC-2017-0159)

On August 23, 2017 ([82 FR 39971](#)), the NRC published a notice in the *Federal Register* requesting public comment on a petition for rulemaking dated April 14 2017, from Matthew McKinley on behalf of the Organization of Agreement States. The petition requests that the NRC revise its regulations to add radionuclides and their corresponding activities to the list of “Quantities of Licensed Material Requiring Labeling.” The petition was docketed on June 21, 2017, and has been assigned Docket No. PRM-30-66. The NRC is examining the issues raised in PRM-30-66 to determine whether they should be considered in rulemaking. Comments should be submitted by November 6, 2017.

On August 24, 2017 ([82 FR 40448](#)), the NRC published a notice in the *Federal Register* providing NRC’s semiannual regulatory agenda (the Agenda) in accordance with Public Law 96–354, “The Regulatory Flexibility Act,” and Executive Order 12866, “Regulatory Planning and Review.” The Agenda is a compilation of all rulemaking activities on which the NRC has recently completed action, proposed, or are considering action. Comments on the Agenda should be submitted by September 25, 2017.
