Dear Ms. Henderson:

In response to a number of RATS notifications, Pennsylvania wishes to formally notify the Nuclear Regulatory Commission (NRC) that we achieved compatibility through incorporation by reference of the relevant chapters of Title 10 Code of Federal Regulations (CFR). Chapters are incorporated in their entirety with the sections not being incorporated specified. Also important to note is that incorporation is not tied to any specific date so that as changes occur in the referenced NRC regulations, they are automatically incorporated into the Pa. Code. The only exception to this was the recent regulation we promagated to incorporate the new Part 37. That regulation was transmitted to the NRC in our RATS 2013-1/2016 letter.

All NRC regulations that are incorporated by reference are listed in Title 25 Pa. Code, Chapter 215. This chapter contains general provisions that apply to all chapters in Article V, relating to Radiological Health. However, for convenience of the licensee, all chapters of the Pa. Code also contain the CFR references to incorporation which correspond to that particular chapter; for example, reference to Part 20 is repeated in Chapter 219, Standards For Protection Against Radiation.
