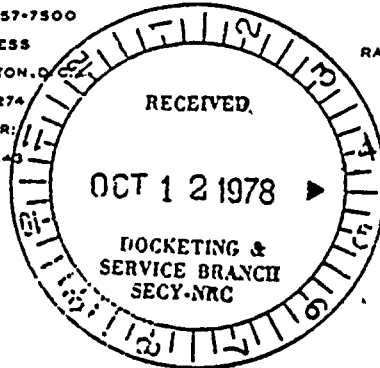

As counsel for Rochester Gas and Electric Corporation, I enclose the following:
