Subject: Revision 1 to Application for Amendment 16 to Standardized NUHOMS® Certificate of Compliance No. 1004 for Spent Fuel Storage Casks (Docket No. 72-1004)

Reference: "Application for Amendment 16 to Standardized NUHOMS® Certificate of Compliance No. 1004 for Spent Fuel Storage Casks, Revision 0 (Docket No. 72-1004)," TN Americas LLC submittal E-48527 transmitted to the NRC on June 29, 2017.

As a result of the public meeting with NRC held on August 10, 2017 to obtain preliminary feedback from NRC staff regarding the proposed changes to Certificate for Compliance No. 1004 as part of the Pilot for Graded Approach for Certificate of Compliance Format, Content, and Selection Criteria review for Amendment 16, TN Americas LLC (TN) is providing this revision to the application.

For those proposed changes to the Certificate of Compliance (CoC) and Technical Specifications (TS) for which the NRC staff provided comments or had questions, TN has considered the evaluations to address the NRC feedback. TN has also added to the header of each of the 99 individual evaluation forms to identify the form # (as provided in the NRC feedback) and the revision number for the form.

If there was no initial feedback from NRC for a particular form, the revision level is indicated as Revision 0. If there was feedback but no changes were made, the revision level is also indicated as Revision 0, with additional indication regarding why no changes were made. For those evaluations in which changes have been made, the revision level is indicated as Revision 1 and the changes in the body of the evaluation form are tracked so that they are clearly discernable.

An evaluation form for each of the current CoC requirements is provided in Enclosure 1. Similar evaluation forms for each of the sections of the TS and the TS tables and figures are provided in Enclosures 2 through 7. For information, a revised high-level summary of the results of the evaluation is given in Enclosure 8. The NRC initial feedback document from the August 10, 2017 public meeting is provided for information as Enclosure 9.


As discussed in the original amendment application and during the public meeting on August 10, 2017, the CoC, TS, and UFSAR documents are not being word-processed and provided at this time. After NRC's review of the proposed disposition of each of the individual CoC conditions and TS items, the proposed CoC and TS documents and UFSAR changes will be word-processed and provided to the NRC for review.

This submittal is being provided as an electronic submission, using the optical storage media (OSM) provision from Section 4 of the NRC Guidance for Electronic Submissions to the NRC. Accordingly, we have included a Document Components listing and OSM#1 listing at the end of this cover letter.
