As discussed with our NRC EOS Project Manager, Yen-Ju Chen, TN discovered that the public FSAR cover page was inadvertently shown as "Revision 7" instead of "Revision 0." Please replace the file in the referenced FSAR Revision 0 transmittal with the file provided in Enclosure 1. This is a file containing the combined public version of the FSAR Cover Page through Chapter 3 for Revision 0 of the FSAR. Since this is a replacement file from the original FSAR Revision 0 enclosure, no enclosure cover page is included in this submittal. However, the replacement file is denoted in the enclosure list herein and in the Document Components listing herein as Enclosure 1 and Enc 1, respectively.

This submittal is being provided as an electronic submission, using the optical storage media (OSM) provision from Section 4 of the NRC Guidance for Electronic Submissions to the NRC. Accordingly, we have included a Document Components listing and an OSM#1 listing at the end of this cover letter.
