SUBJECT: U.S. NUCLEAR REGULATORY COMMISSION DENIAL OF PLUS, LLC
REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE

Dear Mr. Gupta:

By letter and affidavit dated August 16, 2017, received on August 29, 2017, you requested that information be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390(a)(4). In particular, you requested that in Attachment B, pages 16-27 of the Supplemental Information be withheld from public disclosure.

Your reasons for requesting our withholding of this information from public disclosure were that these documents contain proprietary information that (1) has not been made available to the public and has been held in confidence by Plus LLC since its inception and continues to remain confidential, (2) is of a type of customary held in confidence, (3) is being transmitted to U.S. Nuclear Regulatory Commission (NRC) in confidence, (4) is neither available in public sources nor generally in public domain, and (5) is highly likely to cause substantial harm to Plus LLC's competitive position because it will permit competitors to create similar products and either reduce or foreclose future business opportunities.

We have reviewed the documents in your amendment request and all of the supporting information in accordance with the requirements of 10 CFR 9.17 and 10 CFR 2.390, and have concluded the documents do not contain information that should be withheld from public disclosure and that contain proprietary, confidential commercial and/or financial information. Accordingly, we have concluded that the information sought to be withheld from public disclosure does not meet the requirements of 10 CFR 9.17 and 10 CFR 2.390. Therefore, your request to withhold Attachment B, pages 16-27 of the Supplemental Information, from public disclosure is denied.

The staff cannot return any portion of the document in question because the NRC needs to retain the information in the document to review your August 16, 2017, application for amendment of your NRC License No. 06-35274-01E. In accordance with 10 CFR 2.390(c), the information sought to be withheld will be placed in the Commission's Public Document Room 6 days from the date of this letter.
