SUBJECT: NRC CONSENT TO DIRECT LICENSE TRANSFER AND AMENDMENT NO. 02

TERMINATING NRC LICENSE NO. 21-32767-01

Dear Mr. Johnson:

By letter dated June 7, 2017 (ML17160A368, received at the U.S. NRC Region III office on June 9, 2017), Mid-Michigan MRI, PET-CT submitted to the U.S. Nuclear Regulatory Commission (NRC) Region III Office a Request for Consent to a direct License Transfer of NRC Materials License No. 21-32767-01. Based on the information provided, we understand that as a result of an acquisition of Mid-Michigan MRI, PET-CT by Edward W. Sparrow Hospital, Lansing, control would be directly transferred to Edward W. Sparrow Hospital, Lansing. We further understand that this transfer will not result in any change to the licensed materials, persons using the licensed material, location of use of licensed material, or persons responsible for the licensee's radiation safety program, other than the Radiation Safety Officer (RSO).

In addition, we understand that the RSO will change together with termination of this license, and incorporation of the licensee's 1215 E Michigan location of use into the Edward W. Sparrow Hospital, Lansing radioactive materials license, NRC License No. 21-01430-01. Based on information provided, we understand that the licensee intends that all of the licensee's assets will be transferred to Edward W. Sparrow Hospital, Lansing. In your letter, accordingly, you confirmed that, upon completion of the attached termination and the amendment of the Edward W. Sparrow hospital license, NRC License No. 21-01430-01, adding the 1215 E Michigan location of use to that license, all residual licensed material from Mid-Michigan MRI, PET-CT is now under the control of Edward W. Sparrow Hospital, Lansing. We have noted that submitted documentation confirmed completion of the transaction on July 1, 2017.

Based on its review, the staff has concluded that all licensable radioactive material at 1215 E Michigan, Lansing, Michigan, has been transferred from Mid-Michigan MRI, PET-CT, NRC License No. 21-32767-01 to Edward W. Sparrow Hospital, Lansing, NRC License No. 21-01430-01. Based on this conclusion, no further remediation or actions with respect to NRC regulated material are required on the part of Mid-Michigan MRI, PET-CT. The NRC understands that all records concerning the safe and effective decommissioning of the 1215 E Michigan facility have been transferred to and will be maintained by Edward W. Sparrow Hospital, Lansing, NRC License No. 21-01430-01.

In addition, based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the proposed transfer. Accordingly, NRC license number 21-32767-01 is hereby terminated. A copy of the terminated license – Amendment No. 02 – is enclosed.
