In correspondence dated June 8, 2017 you indicated that you wish to remove and release the facility at 43211 Dalcoma Dr., STE 9, Clinton Township, MI for unrestricted use.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the location of use and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this area of use and it is suitable for unrestricted use.
