We note that Figure 2-1 depicting your organizational structure reflects proposed Amendment Number 63 to your technical specifications. Should this proposed amendment not be approved by the NRC the figure may require correction. This item was discussed by Mr. G. Napuda of our staff with you and Mr. K. Easterbrook of your staff on July 13, 1984. A number of minor editorial comments were also provided you at that time.
