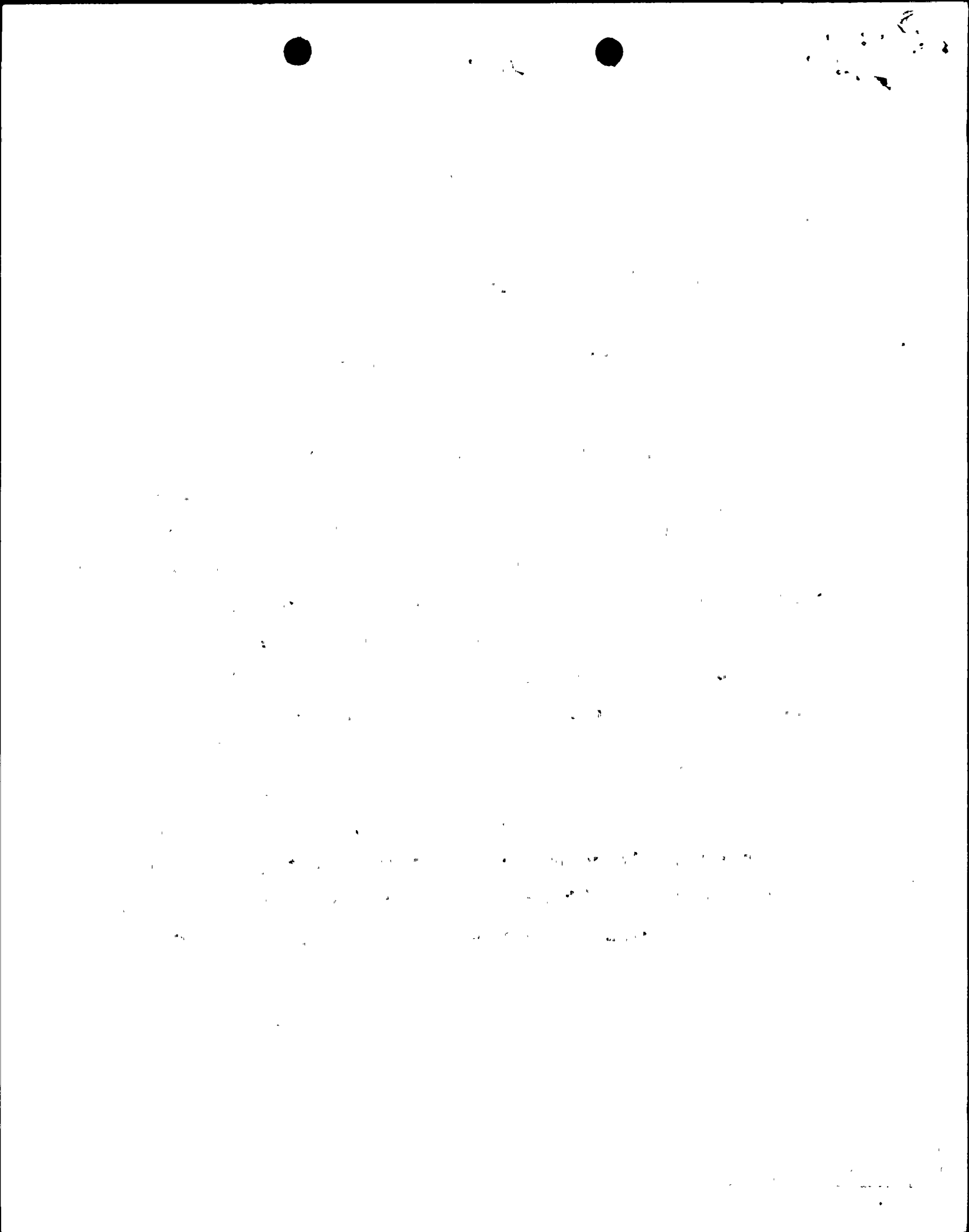

The proposed technical specification change is set forth in Attachment A to this Application. A safety evaluation is set forth in Attachment B. The proposed change does not involve a significant change in the types or a significant increase in the amounts of effluents or any change in the authorized power level of the facility. The change involves a single safety issue, and does not involve a significant hazards consideration. Therefore, this change is a Class III Amendment in accordance with 10 CFR 170.22.



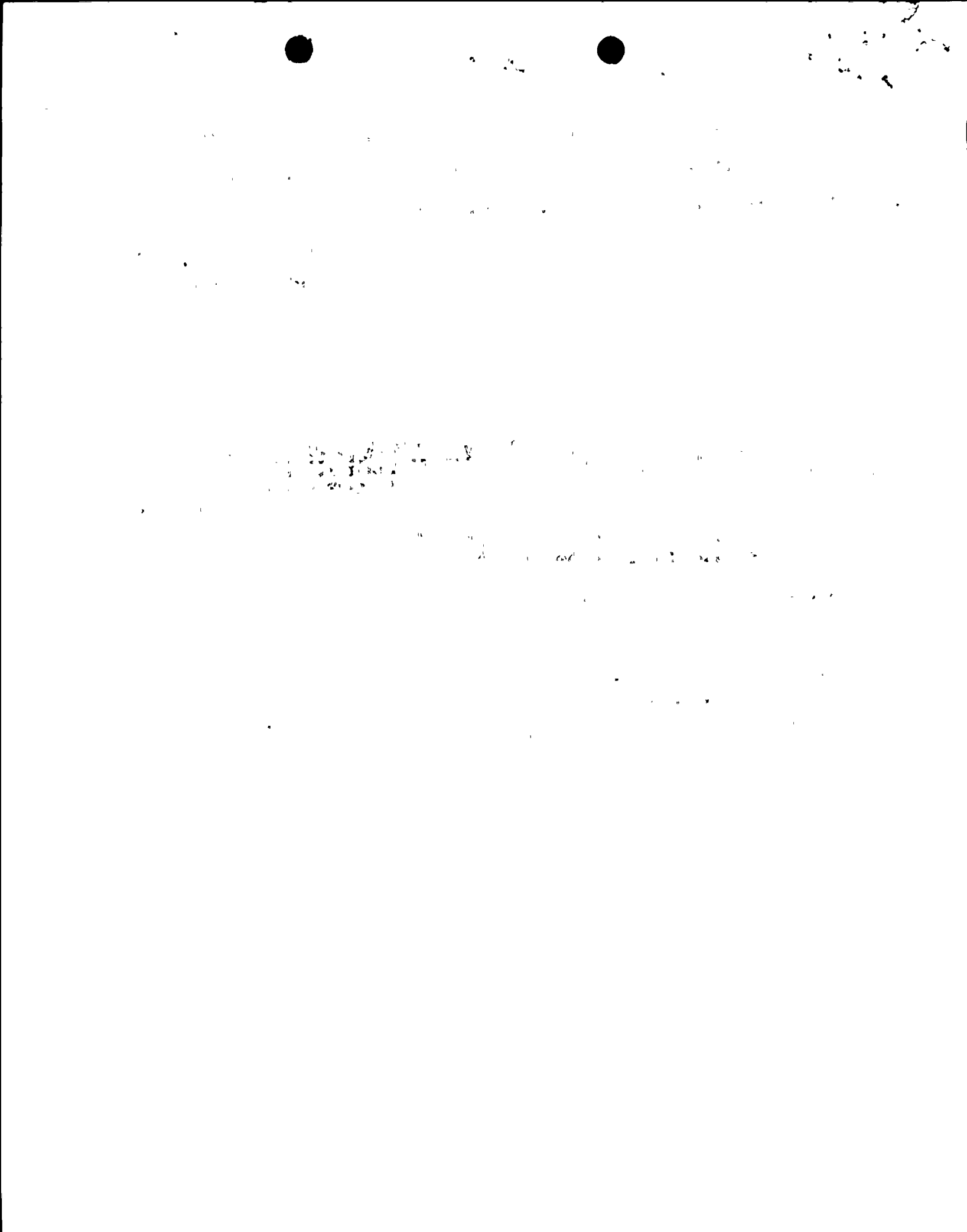


