Dear Mr. Ridenhower:

The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed the cost estimate for NRC License Number 24-24817-01 in accordance with NUREG-1757, Volume 3, Revision 1 "Financial Assurance, Recordkeeping, and Timeliness." Based on this review, the NRC staff has determined that the decommissioning cost estimate, \$254,106.88, is acceptable. For future submittals, you need to provide more detailed descriptions of the areas of use. For example, the areas where packages are received are included as an area of no impact, but no justification for this was provided in the original cost estimate.

In addition, the NRC staff has completed its review of Amendment No.1 to Supplemental Trust Agreement dated July 21, 2017. Based on this review, the NRC staff has determined that the financial assurance mechanism and supporting documentation conforms to NRC guidance. Pursuant to your request, we sent a letter to Wilmington Trust, regarding the NRC's acknowledgment of the reduced value of the Trust Fund to \$254,106.88. A copy of the letter is enclosed for your records.
