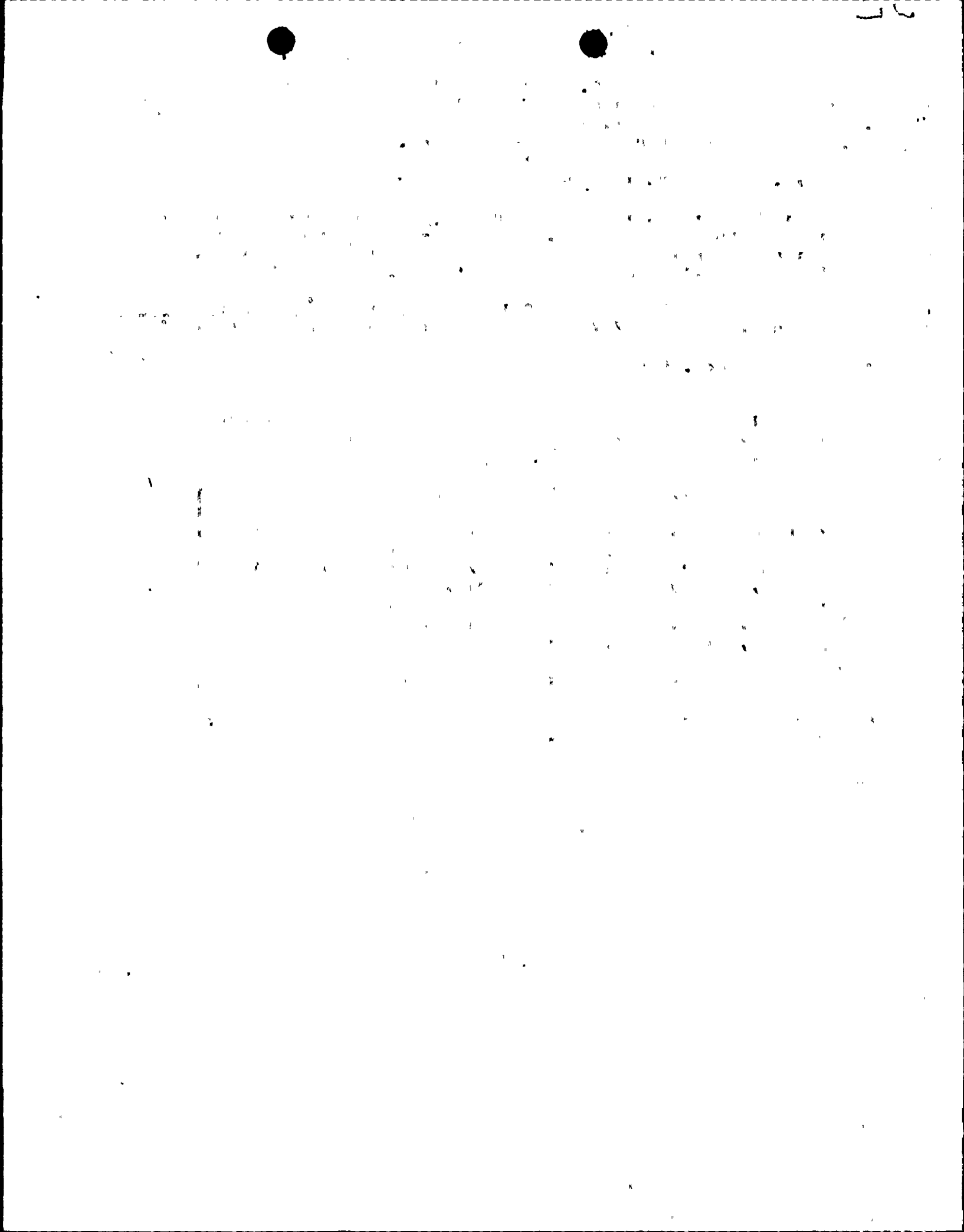

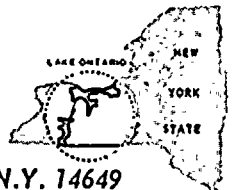

Dear Mr. Crutchfield:

With reference to NUREG 0737, Item II.B.4, Training for Mitigating Core Damage, the R. E. Ginna Nuclear Power Plant training to Mitigate Core Damage will not begin prior to April 1981.

We purchased this training program to be presented by Westinghouse Corporation in January 1981, expecting the program to begin during April 1981. They have notified us they are unable to begin the presentation by April 1981 due to a manpower shortage. Since this notification we obtained a tentative schedule where the class will be provided five times on the noted schedule:

1. June 9, 1981 through June 12, 1981
2. June 16, 1981 through June 19, 1981
3. June 30, 1981 through July 3, 1981
4. July 28, 1981 through July 31, 1981
5. August 11, 1981 through August 14, 1981

This schedule will complete the training of Mitigating Core Damage prior to October 1981.
