Dear Mr. Denton:

Pursuant to 10 CFR 50.71(e), Rochester Gas and Electric hereby submits the Updated Final Safety Analysis Report (UFSAR) for the R. E. Ginna Nuclear Power Plant. One signed original and twelve additional copies of the UFSAR are enclosed.

The information contained in the UFSAR is considered to accurately present changes, as of June 16, 1984, made to Ginna Station since submitting the original FSAR as necessary to reflect information and analyses submitted to the NRC or prepared pursuant to NRC requirements. The enclosed UFSAR is a completely new document without the pages from the original FSAR, but retains all the applicable information from the original FSAR. During the preparation of the UFSAR, RG&E modified the format such that it essentially follows that outlined in Regulatory Guide 1.70, Revision 3. This initial UFSAR is a "clean" document without change bars and revision numbers. The subsequent revisions will have all changes identified.

Future revisions of the UFSAR will be submitted at least annually and will reflect all the changes up to six months prior to the date of submittal.
