Also in this amendment, we deleted Condition No. 13, as it appeared on Amendment No. 24, because the regulations in 10 CFR 35.605 cover this requirement.

We also deleted some extraneous language, such as "with attachments," from some of the documents listed in current Condition No. 13, as this language was unnecessary.
