Hi Michael,

We have reviewed your four draft license amendments and they appear to be ok. Regarding the fees, it is \$1,300 each for the XSNM cases and \$2,700 for the XCOM case and \$1,300 for the IW009 case, for a total of \$6,600. As of 29 August the minor amendment fees are \$2,600 for any minor amendment – for a total of \$10,400. Please work with Stanley Freeman, our expert on all things fee related for NRC's receipt of the additional funds (\$6,600 - \$5,200 already authorized).
