We have reviewed your request for consent to transfer control of several licenses transmitted by letter dated April 14, 2017, as supplemented by letters dated July 14, August 31, and October 4, 2017. We find your request acceptable. An order approving the indirect transfer of control is provided in Enclosure 1. A Safety Evaluation Report documenting the basis for our findings is provided in Enclosure 2.

The order will be published in the *Federal Register*. This action closes efforts under Cost Activity Code L33441.
