NRCB10 BRIEF PROJECT TITLE AND WORK DESCRIPTION

(a) The title of this project is: **Adobe Software Licenses and Support**

(b) Background:

The NRC uses Adobe software for creating, converting, editing and signing PDF documents, as well as a comprehensive content management platform solution for building websites, mobile apps and forms.

NTT/DSFG manages the NRC desktop and laptop, which includes Adobe, and provides the software licenses until its ITISS contract expires. Currently, the NRC is dependent upon the Adobe software provided under the ITISS contract. However, an updated version of Adobe software is not intended to be purchased before the expiration of the ITISS contract. Therefore, in order to avoid an interruption in services, the NRC must procure NRC-owned Adobe software licenses and associated support services to prevent any degradation in the quality of IT support provided to the NRC user community related to the development of graphics. This action also minimizes risks during the transition from the current contractor owned, contractor operated model under the ITISS contract to a government owned, contractor operated model.

(c) Objective:

The objective of this acquisition is for the U.S. Nuclear Regulatory Commission (NRC) to procure Adobe Software Licenses and Support. This purchase will be to replace the existing licenses currently provided by and managed by the NRC’s ITISS Contractor.

(e) Limited Source Justification:

This brand name procurement of Adobe software licenses will allow the NRC to continue to have the ability to work with PDF documents and forms when the ITISS contract expires. Adobe software has also been tested, secured and is an integral part of the NRC’s current enterprise architecture and technical reference model.

Even though a newer version of COTS software could currently meet the NRC's requirements, the NRC does not currently intend to replace its investment in the Adobe software. To do so would cause the NRC to incur significant additional cost, would be highly disruptive and would introduce significant risk to the NRC. Standards for agency software toolsets are established and maintained for several years to maximize the return on those investments and to minimize disruption to agency operations items would require a 100% equipment refresh at a cost estimated at 5 times the cost of replacing only what is needed.
