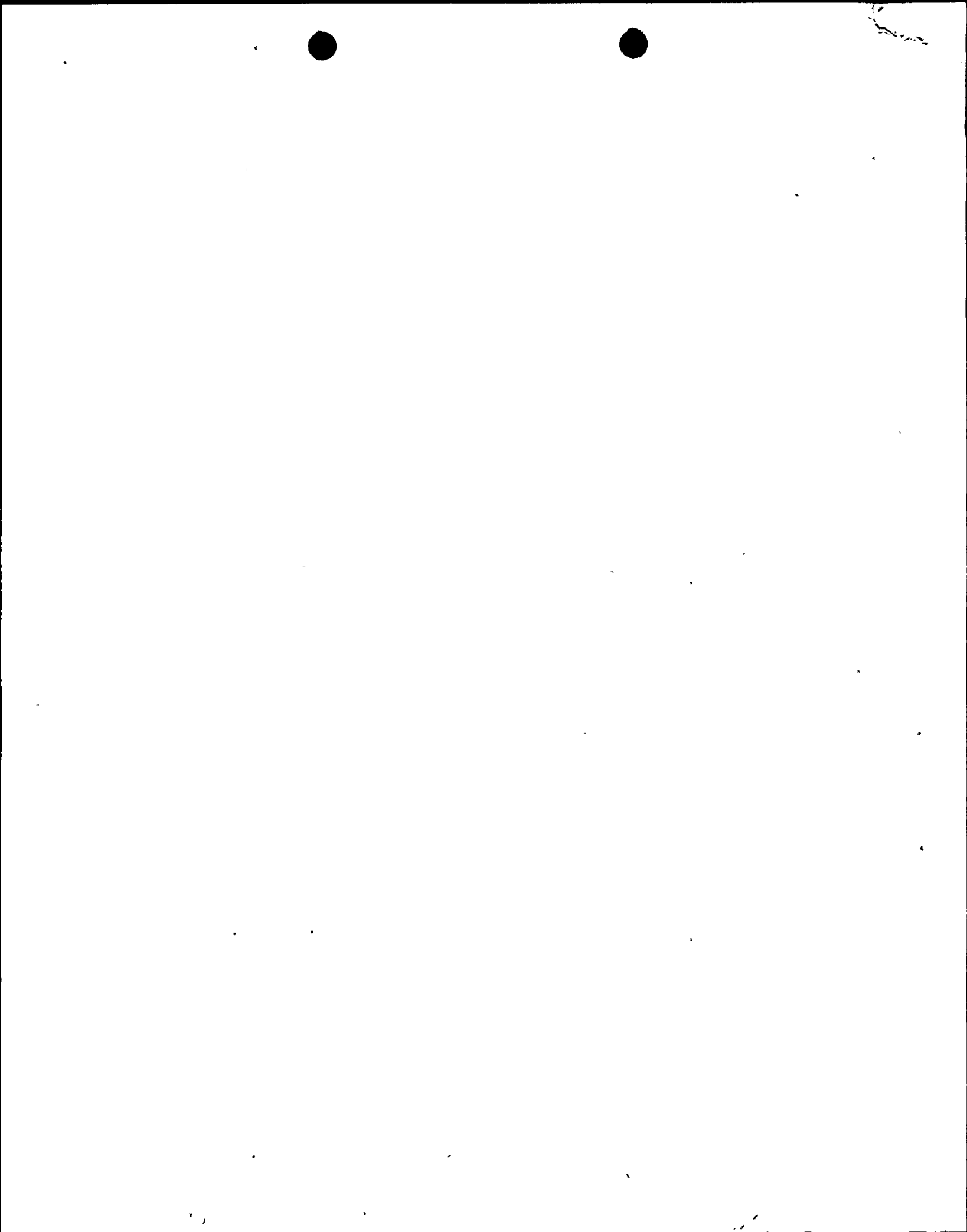
Subject: Staff Briefing on Sacrificial Shield Wall, Pipe Whip Restraints,  
and Related Structures for Washington Nuclear Project No. 2 (WNP-2)

On February 6, 1980, your representatives briefed members of the NRC staff on the problems and corrective actions relating to the WNP-2 sacrificial shield wall, pipe whip restraints, and related steel. While this presentation basically addressed the topics of WPPSS letter No. G02-80-28 of February 1, 1980, additional aspects of these topics were discussed during the presentation.

Enclosure A to this letter provides a transcript of the presentation and ensuing discussions. You are requested to review the transcript and submit any substantive corrections in writing to this office within 20 days of the date of this letter.
