SUBJECT: ADVANCED POWER REACTOR 1400 DESIGN CERTIFICATION  
APPLICATION - SAFETY EVALUATION WITH NO OPEN ITEMS FOR  
CHAPTER 19.5, "AIRCRAFT IMPACT ASSESSMENT"

By letter dated December 23, 2014, Korea Electric Power Corporation (KEPCO) and Korea Hydro & Nuclear Power Co (KHNP), Ltd. submitted an application for a design certification of the Advanced Power Reactor 1400 (APR1400) Standard Design.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Safety Evaluation (SE) with no Open Items for Chapter 19.5, "Aircraft Impact Assessment" (ML17276A082). Unless otherwise stated in the SE, the staff's review was based on Revision 1 of the application. The SE is being provided to support a meeting of the subcommittee of the ACRS scheduled for February 21, 2018. The ACRS full committee meeting will be held after the subcommittee meeting.

The staff concludes that the SE does contain information exempt from public disclosure. The NRC will withhold the SE from public disclosure for ten business days to allow KHNP the opportunity to verify the staff's conclusion that the SE contains such exempt information. Therefore, the staff requests that the ACRS withhold the SE from public disclosure until the information has been released publicly in the Agencywide Documents Access and Management System.
