The reference letter notified the staff that the RCIC system would not be maintained in the WNP-2 Equipment Qualification Program. Subsequently in a phone conversation between Messrs. R. Auluck and A. Masciantonio (NRC) and Mr. P. L. Powell (SS) on March 6, 1984, it was requested that it be confirmed that those RCIC valves required for containment isolation remained in the Equipment Qualification Program.

Accordingly, the Equipment Qualification Program and RCIC system have been reviewed. Those RCIC valves required for containment isolation remain in the Equipment Qualification Program.
