Dear Ms. Adams:

This concerns your notification letter dated June 30, 2017, informing the NRC that Dr. Joseph Santoro had completed his three proctored microspheres cases. In accordance with License Condition 12.C., physicians permitted to work as authorized users for microspheres must have completed three hands-on patient cases supervised in the physical presence of a manufacturer representative for each type of Y-90 microsphere for which the individual is authorized. As discussed by telephone with Ms. Ruth Shanley on August 29, 2017, the mapping case could not be considered as a proctored case because it did not involve the use of microspheres. Because you informed us that you are not currently able to provide the additional information, the third case, required to complete the requested action, we have voided your request. This action is taken without prejudice to the resubmission of your request.
