During their regular meeting of June 10, 1985, the Washington State Energy Facility Site Evaluation Council reviewed and subsequently adopted a series of motions indicating their concurrence with the following requests for amendments to NRC's Operating License for the Washington Public Power Supply System's Nuclear Plant No. 2.

Apr. 19, 1985	Surveillance Requirement 4.6.1.7 - Drywell Air Temperature Measurements
May 16, 1985	Automatic Depressurization System Logic Modifications, Lic. Condition 18

The Council's concurrence with the above amendment requests was telephonically transmitted to Mr. John Bradfute, NRC's WNP-2 Project Manager, on June 17, 1985. We should also note that the Council received copies of these amendments from the Supply System in accordance with the notification requirements of 10 CFR 50.91.
