We would like to amend our license to reflect the following changes.

- 4) Please amend Item #10, Part B in our license to change the facility name referred to as the Radiation Oncology Center to Genesys Hurley Cancer Institute, which is the correct name of the facility located at 302 Kensington Avenue, Flint, MI.

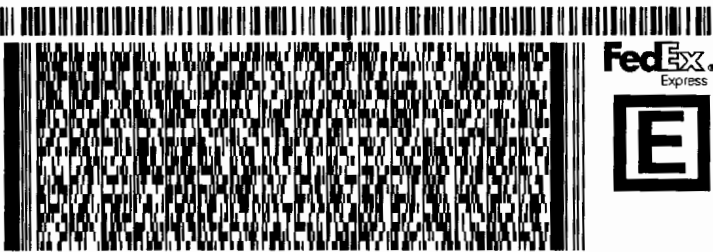

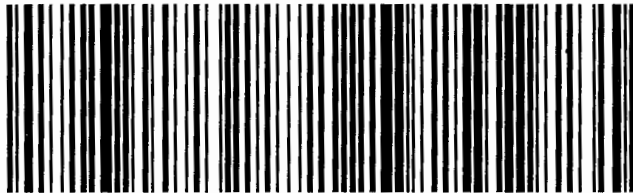
