The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2016-020) on September 21 2016, to determine whether an individual was discriminated against for raising safety concerns, while employed by Tote Services and working on the NS Savannah. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the individual was subject to discrimination for raising safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
