Dear Ms. Beckfield:

It has come to our attention that Amendment No. 117 to your NRC Material License No. 24-00513-32 issued on October 5, 2017, contained errors.

In Condition No. 23, some of the language in the header was missing: "....120 days, other than that held in accordance with 10 CFR 35.92, for...".

A new Condition No. 32 prohibiting the release of licensed material in field applications was inadvertently not listed. This addition resulted in your tie-down Condition becoming Condition No. 33. Condition No. 30's reference to Condition No. 32 has been changed to refer to Condition No. 33.

Condition No. 27 had an alignment and spacing problem that is now resolved.

Finally, a recent change in NRC's materials licensing policies permits us to extend the expiration date on byproduct materials licenses by 5 years.

Enclosed is a corrected copy of Amendment No. 117 that reflects the changes and corrections above, as well as the additional 5 years to the expiration date in Subitem No. 4, which is now December 31, 2030.

We apologize for these errors and for any inconvenience they may have caused.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.
