
Reference: Letter, dated June 3, 1999, JV Parrish (SS) to NRC, "Request for Amendment, Licensee Name Change"

This clarification is provided as requested during a July 19, 1999, telephone conversation with JS Cushing (NRC) and JD Arbuckle and RN Sherman of the Supply System.
