

The projected schedule and scope of emergency drills and exercises for Plant 2 were furnished by reference a. This committed to the inclusion of protected area evacuation by Exercise '93. Tentative objectives and limitations for Exercise 89 were furnished by reference b.

Three draft copies of the current exercise scenario packet are enclosed for your review and approval. Objectives differ from the earlier submission by deletion of what had been Supporting Objective 2c 3) on accountability. After close examination of the accountability contingency we believe that a modification of both the hardware and the software is necessary in order to bring this system to the level of effectiveness we deem appropriate. It is our intent to proceed with the design and installation of this modification and then conduct the accountability drill at a later time. As soon as the work package is defined and integrated into the ongoing work schedule we will advise you of the time frame for this drill.
