The reference letter informed the Staff that the Supply System had commenced a plant specific effort to develop an Improved Technical Specification (ITS) for WNP-2 based on standards developed by the Boiling Water Reactor Owners Group and the NRC Interim Policy Statement on Technical Specification Improvements. Tentative submittal was scheduled for September 1990. Subsequent review of Industry/NRC review schedules on the lead plant ITS submittals has caused a revision of this schedule such that the WNP-2 ITS submittal is now scheduled for March 1991 with implementation tentatively scheduled for October 1991.
