The reference letter authorized the use of ASME Code Case N-416 at WNP-2 for application in the repair or replacement of Class 2 piping for WNP-2 with the limitations stated in the "Inquiry" and "Reply" section of the Code Case.

The letter stated that documentation of the use of the Code Case should be included in the FSAR. In FSAR Amendment 42, issued in August 1990, we documented the first use of the Code Case (page C.3-116).

As use of this Code Case has now been incorporated into Regulatory Guide 1.147, and as this guide does not require documentation of the use of Code Cases, we do not plan on documentating additional use of Code Case N-416 in the FSAR.
