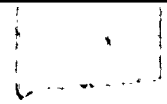

Reference: Letter, RA Scarano (NRC) to GC Sorensen (SS),
"Comments on WNP-2 Emergency Preparedness Plan
Changes, Rev. 10", dated April 9, 1991

Per 10CFR50.54(q) we are submitting revision 11 of the Emergency Preparedness Plan. In revision 11 there are five changes that may be perceived as decreasing the effectiveness of the Emergency Plan. In taking a conservative approach to 10CFR50.54(q) they are being submitted for approval prior to implementation.

In addition, the reference letter indicated that there were two changes from revision 10 that were identified as changes that decreased the effectiveness of the Emergency Plan and were not approved prior to implementation of the revision. These items are:

1. Pages 6-1 through 6-22

Revision 10 of the Emergency Plan was not consistent with EPIP 13.1.1 as agreed to by the NRC and the Supply System and that the change may be acceptable after revision to conform to EPIP 13.1.1. This is being tracked by Open Item 50-397/EP-10-01.

Response: Revision 11 changes of the Emergency Plan are consistent with EPIP 13.1.1 which we believe closes this issue. (Also, see discussion of additional changes to Emergency Plan Section 6 under item 5, page 5.)

2. Page 11-7, section 11.6.1

Field team deployment time of 30 minutes has effectively been deleted. This item is being tracked by Open Item 50-397/EP-10-02.

Response: In researching this issue it was learned that the original wording which described field team deployment was not clearly defined. Originally, it had been interpreted that the field team deployment time clock started from the EOF, and that the 30 minutes was based upon getting the necessary equipment and being briefed. It was later learned that NRC interpretation and the Supply System interpretation differed. Revision 10 attempted to clarify field team deployment; however it was viewed by the NRC as decreasing the effectiveness.

In the reference letter it was stated that this item should be rewritten to insure no Emergency Plan degradation has occurred. It is not our intent to decrease the effectiveness of the Emergency Plan. However, the reality is if field team personnel are not located in the Plant Support Facility during normal working hours it is not possible to meet the 30 minute deployment time.

In lieu of this, we are proposing the wording included in revision 11 for field team deployment.

It has been determined by the 10CFR50.59 evaluation process that this proposed change does not introduce an Unreviewed Safety Question or affect the health and safety of the public.

REVISION 11 CHANGES

1. Emergency Plan section 11.6.1, page 11-7.

The Emergency Plan formerly read (Revision 8):

"Deployment time to have monitoring teams in the field during normal working hours is less than thirty minutes and less than one and one-half hours for team members responding from home during off-shift hours."

Change to read:

"Field team members responding during off-shift hours will report to their emergency duty station within 60 minutes. Field team deployment time from their emergency duty station will be less than 30 minutes."

Justification:

Given the geographical location of the facility and what is possible it has been determined that the commitment as written cannot be met; therefore, a change is necessary.

The purpose for deploying field teams is to validate or backup radioactive release data from the Plant Monitoring System. These release data are used in calculating off-site doses. The calculation is conservative in that the following assumptions are made:

- No chemical reactions.
- No decay.
- Air concentrations are non-depositing.
- Dispersion is limited vertically to 1000 meters.
- There is no vertical shear of the wind direction.
- Flat earth.

These conservatisms result in actual concentration measurements being conservative by a factor of 2 to 20. Therefore, it is highly probable that the field team data would indicate lower offsite dose rates and ground deposition concentrations than originally projected. Protective Action Recommendations (PARs) which are made based on these conservative off-site dose calculations would therefore be conservative.

Changing the field team deployment time from 30 minutes anywhere on site to 30 minutes from their emergency duty station will not affect the PARs. This change will only result in clarification of deployment time. Therefore, the consequences of an accident will not be increased and the health and safety of the public is not affected.

2. Emergency Plan section 4.4.2.1, page 4-26

This section is a description of the Technical Manager. Included in this section is a description of the staff he supervises. The Emergency Plan formerly read:

"Supervises: Technical staff which includes expertise in the following areas:"

It was changed to read:

"Supervises: Technical staff which may include expertise in the following areas:"

Justification:

The Emergency Plan formerly inferred that the technical staff included personnel with all the listed areas of expertise when activated; however, this may not be necessary depending on the nature of the emergency. The Technical Manager has the personnel resources available with all the expertise listed but will only call in the necessary personnel for the emergency needs. Since the personnel resources are available we believe the effectiveness is not decreased.

3. Emergency Plan section 4.4.2.5, page 4-32, item f.

Delete the responsibility of field kitchen operations from the Administrative Support Manager.

Justification:

The responsibility of providing for food deliveries is listed in item 4.4.2.5.f, which negates the need for field kitchen operations. Additionally, there is food stored in the warehouse of sufficient quantities to provide meals for plant personnel and EOF personnel during an emergency. Since the purpose of a field kitchen is to provide the Emergency Response Organization with meals and this is still accomplished, we believe the effectiveness of the Emergency Plan is not decreased.

4. Emergency Plan section 14.4.1, page 14-3.

Delete the Yakima Valley Memorial Hospital from the section.

Justification:

NUREG-0654 L.1 states "Each organization shall arrange for local and backup hospital and medical services". The Supply System has agreements with Kennewick General, Our Lady of Lourdes and Kadlec hospitals. Yakima Valley Memorial Hospital is approximately 87 miles from WNP-2. The other three hospitals are all within the Tri-Cities area. Eliminating this distant facility has little if any impact on our ability to cope with a medical emergency.

Any combination of two of these hospitals fulfills NUREG-0654 requirements for a local and backup medical facility; therefore, we believe the effectiveness of the Emergency Plan is not decreased.

5. Emergency Plan section 6, Table A.2

Delete Table A-2, Examples of Situation Based Emergency Action Levels Tables.

Justification:

Table B-1 (shown as Table A-2 in revision 11) is a generic table for Emergency Classification that exists to provide generic guidance for classification. Table A-2 in revision 10 contains plant specific examples that support Table B-1 emergency classifications. It has been determined that this level of detail in the example tables is not necessary in the Emergency Plan. Deleting the Table A-2 examples does not affect the classification process, but removes a level of detail unnecessary in the Emergency Plan. The level of detail contained in Table A-2 exists in the Emergency Classification Implementing Procedure, PPM 13.1.1, Classifying The Emergency, which is used by the Plant Emergency Director to classify emergencies.

- Table B.1 has been changed to Table A.2. Editorial

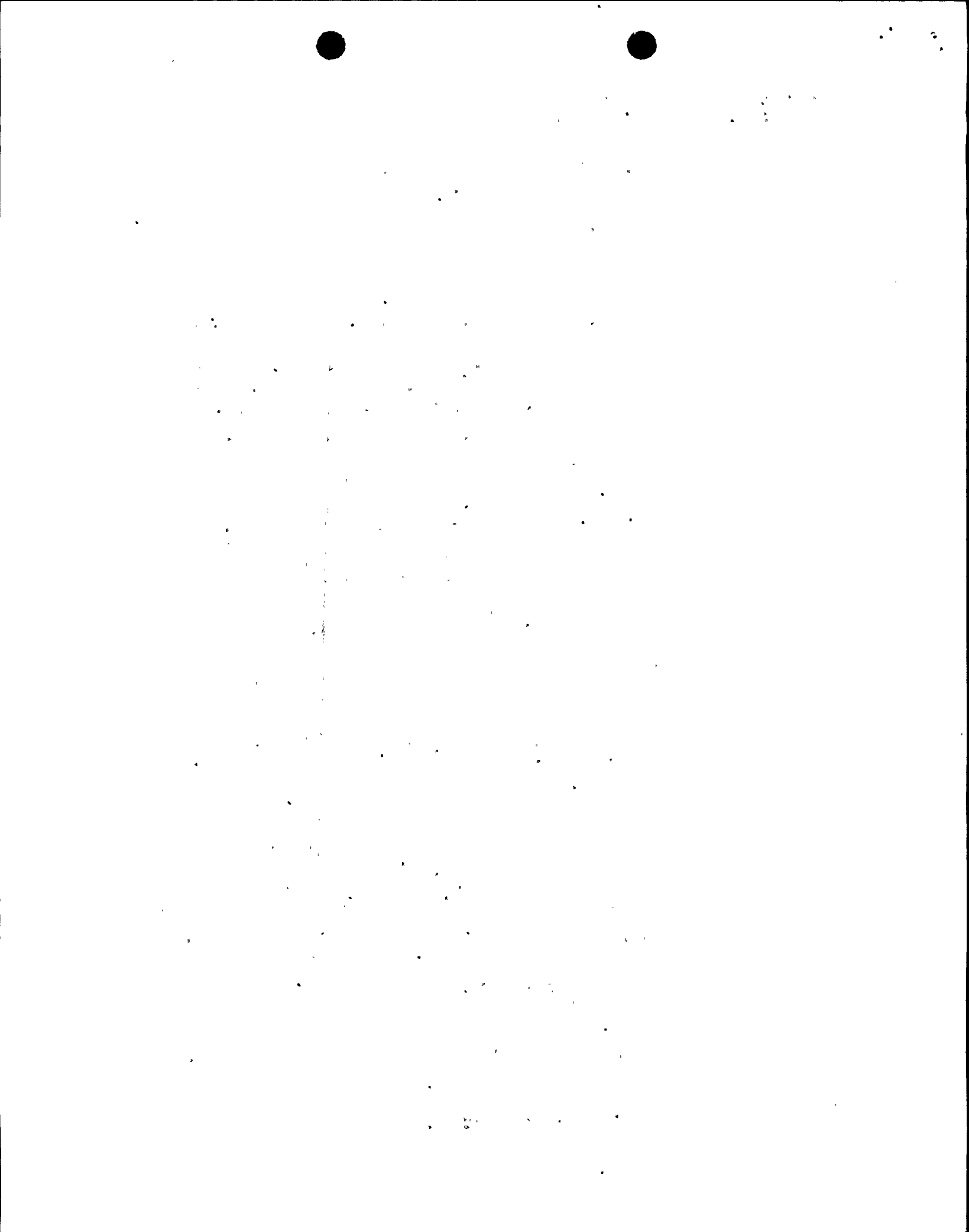

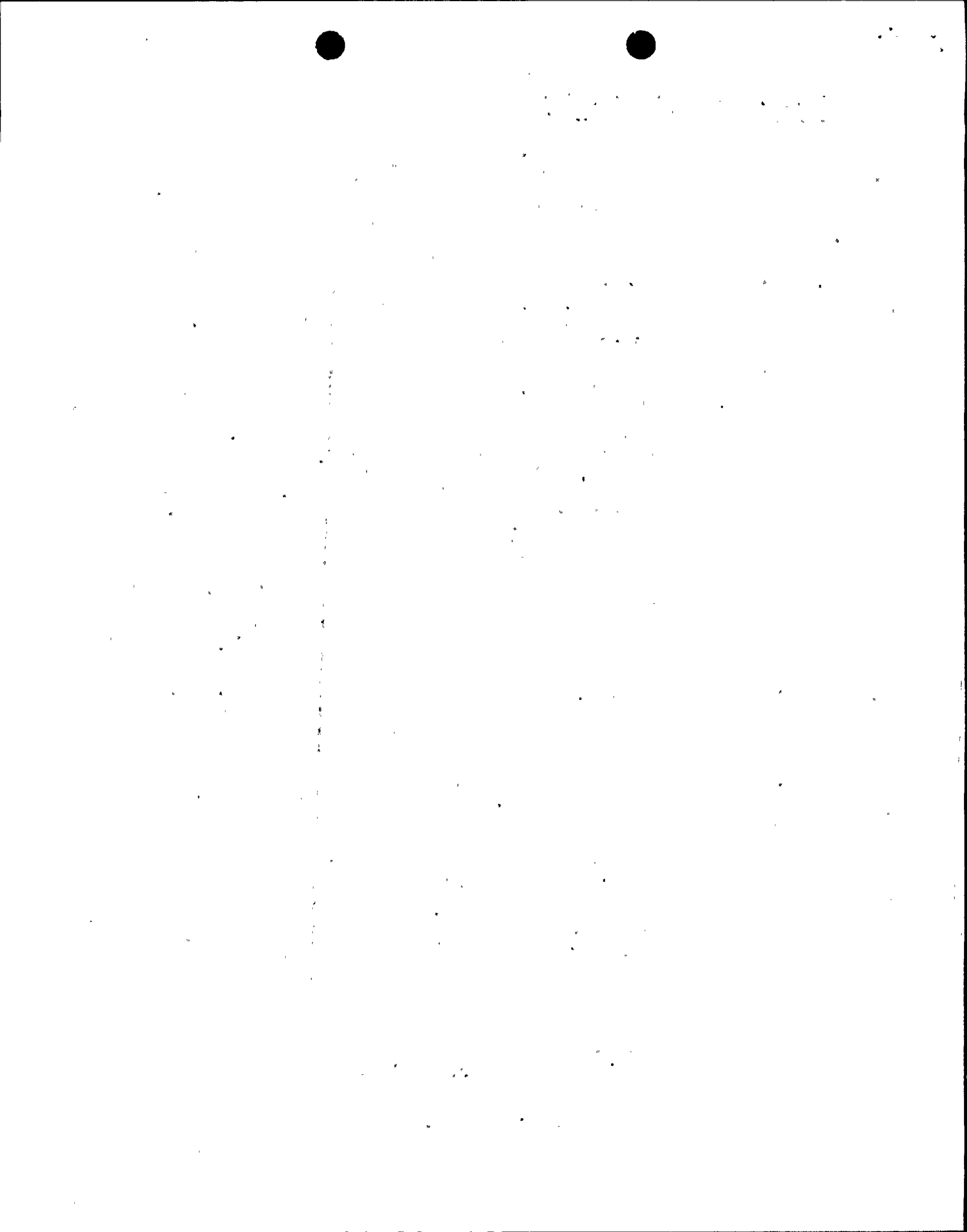
