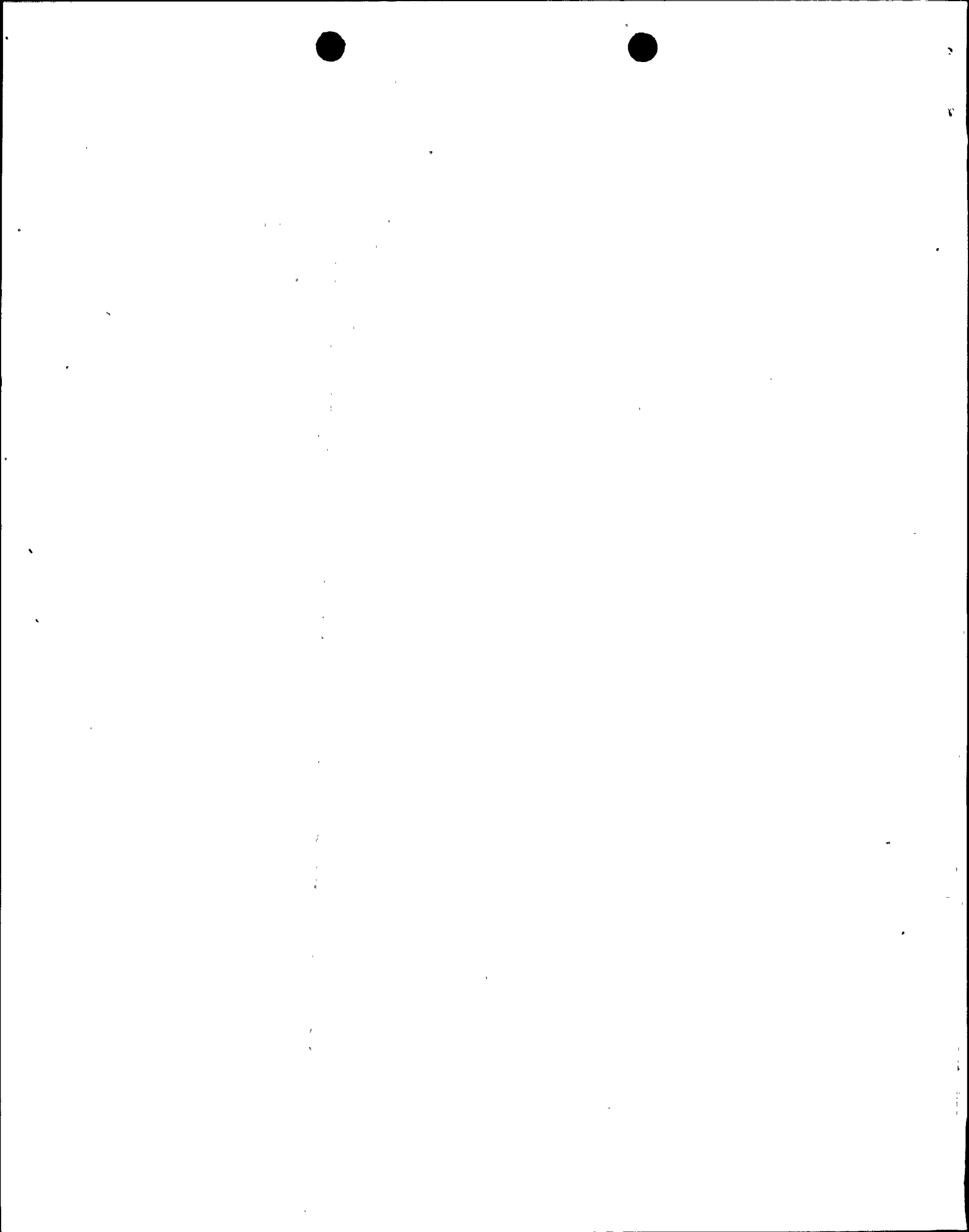

DATE	ACTIVITY <i>(Drill or Exercise)</i>	MINIMUM PARTICIPANTS NEEDED	DESCRIPTION
Tuesday March 17, 1992	Training Drill D 92-1	All Supply System Emergency Centers; WA State DOH will participate in MUDAC	First Training Drill of the 1992 Cycle. Involves activation of all Supply System Emergency Centers. Does not involve Offsite agencies. Expect to escalate to Alert or SAE. Suggest that each center use this to 'break-in' new personnel by doubling up their positions with some of the older, more-experienced personnel.
Tuesday, Nov 3, 1992	Preparatory Drill D 92-2	All Supply System Emergency Centers; Desirable to have Plume Counties & State Agencies involved	Second Training Drill of the 1992 Cycle. This is to prepare us for the NRC/FEMA graded Exercise(s). Suggest the same personnel be used as will be used in the Exercises. State, County & (likely) Hanford DOE agencies will be involved in the Drill. Full blown activation of all Supply System Emergency Centers & partial activation of State/County/Hanford Centers. Expect to escalate to SAE & possibly GE.
Tuesday, Dec 8, 1992	Graded Exercise E - '92 <i>(Evaluated by FEMA & NRC)</i>	All Supply System Emergency Centers; Benton & Franklin Counties; WA State DEM & DOH	NRC/FEMA graded Exercise. Full activation of all Supply System, State & County Emergency Centers. Escalate to SAE or GE. Total number of personnel <i>(Supply System & Offsite Agencies)</i> involved will be in excess of 500. Plan to demonstrate the use of non-Plant Emergency power in appropriate Emergency Centers. Plan to demonstrate the relocation of at least one Emergency Center to a backup center.

Tuesday, Feb 16, 1993	Graded Exercise E - '93 <i>(Evaluated by NRC)</i>	All Supply System Emergency Centers; Desirable to have participative support from the B/F County EOC, State DOH personnel in MUDAC and State DEM/DOH personnel in the State EOC.	This Exercise is graded by NRC only...No FEMA involvement. The Exercise will be conducted 10 weeks after the 1992 Exercise. We are doing this to satisfy NuReg 0654 criteria to conduct Exercises during different times of the year. The Exercise will start on a backshift (<i>ie - early morning hours</i>) and will run into a second shift to demonstrate a shift change. Both of these items are NuReg 0654 criteria, too. Be prepared to provide enough participating personnel to satisfy <u>both</u> shifts (<i>no double-shifting of players allowed</i>). We don't intend to have a 'Preparatory Training Drill' prior to this Exercise; We will depend on the 1992 Exercise to prepare us for the '93 Exercise.
Tuesday, August 24, 1993	Training Drill D 93-1	All Supply System Emergency Centers	First Training Drill of the 1993 Cycle. Intended to be a Casualty Control drill aimed primarily at In-Plant Emergency Centers.
Tuesday, November 2nd, 1993	Training Drill D 93-2	All Supply System Emergency Centers	Second Training Drill of the 1993 Cycle. Intended to be a Casualty Control & Health Physics drill with the focus on off-site MUDAC and Field Team activities.
Tues-Wed, March 29-30, 1994	Training Drill D 94-1	<i>Day one</i> -All Supply System Emergency Centers <i>Day two</i> -All Supply System Non-Plant Emergency Centers; State DOH/DEM & Ingestion Zone Counties	First Training Drill of the 1994 Cycle. Day one of the Drill will be casualty control activities directed primarily at In-plant Emergency Centers. Day two will be 'precursor' ingestion activities directed at the WNP-2 EOF and state/ingestion counties. It is highly recommended the ingestion counties participate in this 'early-on' activity to determine additional training/refinements needed between the Supply System and the counties prior to the Ingestion Preparatory Drill in August and the Ingestion Exercise in September of 1993.

This Drill will be conducted 6 weeks prior to the Exercise, leaving little time to correct deficiencies should they not have been identified in the March 29-30, 1994 Drill earlier in the year. The Drill's primary emphasis will be on ingestion activities on the same scope as are intended to be demonstrated in the 1994 Graded Exercise. Substantial participation by all State/County agencies within the ingestion boundary is paramount.
Wed-Thurs September 7-8, 1994	Graded Exercise E - '94 <i>(Evaluated by FEMA & NRC)</i>	All Supply System Emergency Centers All State & Ingestion Zone Counties	INGESTION EXERCISE - The required Ingestion Exercise to satisfy NuReg 0654/FEMA Rep 1 requirements for the Supply System and for the affected Ingestion Zone State/Counties. As in the Preparatory Drill, the Exercise will be conducted over a two-day period. The first day will be concerned with Plume Phase and In-Plant damage mitigation activities. The emphasis on the second day will switch away from the Plant to offsite Ingestion Zone activities.
March 1995	Training Drill D 95-1	All Supply System Emergency Centers	First Training Drill of the 1995 Cycle. Intended to be a Casualty Control drill aimed primarily at In-Plant Centers. The actual date for this Drill is still indeterminate; It will, most likely, occur in the 3rd week of March.
August 1995	Preparatory Drill D 95-2	All Supply System Emergency Centers	Second Training Drill of the 1995 Cycle. Intended to be a Preparatory Drill for the 1995 Graded Exercise. The actual date for this Drill is still indeterminate; It will, most likely, occur in the second week of August.

Only the Supply System is presently scheduled to be under evaluation <i>(by the NRC)</i> in this Exercise.
March 1996	Training Drill D 96-1	All Supply System Emergency Centers	First Training Drill of the 1996 Cycle. Intended to be a Casualty Control drill aimed primarily at In-Plant Centers. The actual date for this Drill is still indeterminate; It will, most likely, occur in the 3rd week of March.
August 1996	Preparatory Drill D 96-2	All Supply System Emergency Centers; Desirable to have Plume Counties & State Agencies involved	Second Training Drill of the 1996 Cycle. Intended to be a Preparatory Drill for the 1996 Graded Exercise. The actual date for this Drill is still indeterminate; It will, most likely, occur in the second week of August.
