Please find enclosed Amendment No. 32 adding Mark Perna as radiation safety officer (RSO) based on his former temporary status on this license in addition to his current status as RSO on Monongalia General Hospital and Weirton Medical Center in West Virginia.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).


