IMPLEMENTATION OF EOP PHASE II**

Reference: Letter, LF Miller (NRC) to GC Sorensen (SS) dated March 4, 1993, "Issuance of Licenses for Upcoming Licensing Examinations"

The reference letter required formal notification of the implementation of the revision to the Emergency Operating Procedures (EOPs Phase II) which was used in the administration of the March 1993 initial licensing examinations.

This revision of the EOPs was implemented for plant operation on April 9, 1993 after successful conclusion of two cycles of requalification training focusing on these changes. We have assessed the changes which have occurred to the EOPs since the examination materials were generated and have determined that no training impact exists. We therefore believe that there are no restrictions to issuing the subject licenses when they are available.

All successful licensed candidates will be starting requalification training in cycle 93-3 which is scheduled to start April 26, 1993.
