SUBJECT: INITIAL WRITTEN RETAKE EXAMINATIONS (EXAM REPORT No. 50-397/OL-93-02)

On August 26, 1993 the NRC administered initial operator licensing written retake examinations to employees of your company who had applied for licenses to operate your Washington Nuclear Project No. 2 (WNP-2).

As a result of these examinations, one SRO applicant and one RO applicant met the minimum qualification requirements for licensing and were issued licenses.

After the examinations were administered on August 26, 1993, a post examination review and exit meeting were held with members of your staff as detailed in the enclosed Examination Report, 50-397/OL-93-02 (Enclosure 1).
