Dear Dr. Issawi:

Enclosed is Amendment No. 02 to your NRC Material License No. 21-35275-01 in accordance with your request. Please note that your license format has changed in accordance with our new licensing process system.

Also, note that in accordance with NRC policy, License Condition No. 13, referencing the transportation requirement in Title 10 of the *Code of Federal Regulations* (CFR), Part 71, "Packaging and Transportation of Radioactive Materials," has been removed in accordance with current NRC policy. The transportation regulation is now included in the preamble on page 1 of the license.

Finally, in correspondence dated August 2, 2017 you indicated that you wish to remove and release the facility at 5084 Villa Linde Parkway, #6, Flint, MI 48532 for unrestricted use.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the location of use and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this area of use and it is suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.
