SUBJECT: SUMMARY OF JUNE 6, 2017, CLOSED MEETING WITH AREVA INC.
REGARDING FUEL PERFORMANCE

On June 6, 2017, a closed meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of AREVA Inc. (AREVA) at the NRC headquarters campus, Rockville, MD to discuss proprietary information regarding AREVA fuel performance and future plans. The meeting was used to increase the NRC staff's understanding of AREVA's fuel activities, fuel operating experience, and advanced codes and methods. Also, customer needs associated with submitted and planned topical reports were discussed.

The morning session consisted of discussions of boiling water reactor (BWR) and pressurized water reactor (PWR) fuel performance updates. The following topics were discussed: BWR and PWR operating experience, BWR and PWR fuel exams, and BWR and PWR poolside surveillance results and plans.

The afternoon session of the meeting consisted of discussion on BWR and PWR Topical Reports, BWR and PWR advanced methods, advancements in structural dynamics, and AREVA program on enhanced accident tolerant fuel.
