In compliance with the licensing responsibilities delineated in 10 CFR Part 50.54(w)(3), the Supply System reports that the following property and liability insurance coverage for WNP-2 is in force:

Property: \$500,000,000 primary nuclear property damage and decontamination liability insurance with a \$10,000,000 deductible written by ANI/MAELU.

Additionally, Bonneville Power Administration maintains \$560,000,000 in excess nuclear property damage insurance (NEIL II) and \$473,200,000 in business interruption and extra expense insurance (NEIL I) on WNP-2 provided by Nuclear Electric Insurance Limited (NEIL).

Liability: \$200,000,000 primary financial protection is maintained under ANI/MAELU, along with maximum secondary financial protection.
