Subject: Revision to BWXT Nuclear Operations Group, Inc. – Lynchburg, Physical Protection Plan

Dear Sir or Madam:

BWXT Nuclear Operations Group- Lynchburg, Inc. (BWXT NOG-L), forwards the enclosed Revision 21 to the Physical Protection Plan (PPP) in accordance with the provisions of 10 CFR 70.32(e) and 10 CFR 70.34.

The enclosed plan has been revised to reflect changes made due to the east protected area barrier expansion, new Entry/Exit Control Point (EECP), and update Section 16 (Fatigue Management Program). Appendix B was removed and applicable portions of sections 5, 6 & 7 were reinserted back into the body of their respective sections following the completion of Alarm Station upgrades. Additionally, the enclosed plan incorporates the changes submitted under 10 CFR 70.34, and approved by the NRC (reference NRC Safeguards Evaluation Report - Physical Protection Aspect document: Docket 70-27, dated 02/06/17).

BWXT NOG-L is also submitting changes for review under 10 CFR 70.34 and will not implement these changes until approved.

Enclosure 1 to this letter provides a description of the referenced changes. Enclosure 2 is Revision 21 of the PPP which replaces Revision 20 in its entirety. The enclosures contain Confidential National Security Information and as such must be protected in accordance with 10 CFR 95.
