Please confirm that you would like to have both licenses transferred to the proposed new licensee. If you wish to terminate one of the licenses, we will refund the fee that you paid for one of the two license amendments since only one amendment would be needed.
 - MP Mine Operations LLC would like to have both license XSOU8707 and XSOU8827 transferred to the new licensee. Applications for the transfers are attached.

 - O Attached is the organizational chart showing the common and preferred unit holders of MP Mine Operations LLC, the new licensee. MP Mine Operations was formed in 2017 to acquire the assets comprising the Mountain Pass rare earth facility from Molycorp Minerals, the old licensee, and so there is no corporate relationship between the new and old licensee.
- Please clearly identify if the proposed new licensee or any of its parent companies are foreign companies.
 - o MPMO is controlled by two US investment funds, JHL Capital Group and QVT Financial, which combined have a 90.01% economic stake and own 100% of the voting common units. In terms of foreign company involvement, Shenghe Resources, through its subsidiary Leshan Shenghe Rare Earth, owns a 9.99% non-voting preferred stake, and has no voting rights in MPMO.

Procedures are in place for the analysis, documentation, labeling, placarding, shipping, and tracking of all rare earth compounds and mixtures, and the associated thorium and uranium contaminants, which are exported under the license.
- Please describe the plan for the transfer of required records, including those required by 10 C.F.R. § 110.53, and provide a commitment by the proposed new licensee to maintain the records received from the current licensee.
 - o Included in the Asset Purchase Agreement were all manufacturing data and information, operating instructions, documentation, operating records, files, and data. These records have been maintained and procedures are in place to continue, via either paper or electronic means, to maintain the required records under 10 C.F.R. § 110.53.
- Describe any changes in personnel or duties related to the export program.
 - o There are no changes and John Benfield will continue to be named as the applicant contact and will be responsible for all duties related to the export program.
- Describe any changes in location, facilities, equipment, or procedures related to the export program.
 - o The location at 67750 Bailey Road, Mountain Pass, CA 92366 will be the sole party to the export under this license. Although the principles of beneficiation of the ore have not changed, some procedural improvements related to cost reductions and product recoveries have been, or will be made, for the production of materials which will be exported under this license.
- Also, the Asset Purchase Agreement provided with the applications indicates that there are a
 total of 79 pages; however; only 38 pages were submitted. To ensure that the administrative
