By application dated August 7, 2017, NAC International, requested renewal of Certificate of Compliance No. 9270, for the Model No. NAC-UMS Universal Transportation Package.

NAC submitted the consolidated application in August 2016, to incorporate the supplements in the certificate of compliance. In the consolidated SAR, NAC incorporated all supplements previously approved by U.S. Nuclear Regulatory Commission (NRC). The staff also reviewed the operating and maintenance procedures for the package and found them to be adequate.

CONDITIONS

The following changes have been made to the certificate of compliance:

Section 3b has been updated to reflect the consolidated application received August 3, 2016.

Condition No. 10 has been updated to reflect an expiration date of October 31, 2022.

The references section has been updated to reflect the consolidated application received August 3, 2016, and to include this renewal request.
