

**U.S. Nuclear Regulatory Commission  
First Report in Response to the  
Social Security Number Fraud Prevention Act of 2017**

**Background**

On September 15, 2017, the President signed into law the Social Security Number Fraud Prevention Act of 2017 (Public Law 115-59). As required by the Act, the U.S. Nuclear Regulatory Commission (NRC) has identified the title and identification number of documents sent by mail that were used by the agency during the past year and included an individual's complete social security number. In its effort to identify such documents, the NRC solicited input from all Headquarters and Regional Offices.

**Plan for Compliance**

The NRC will issue regulations consistent with the Act by September 15, 2022. The regulations will specify the circumstances under which inclusion of a complete social security number on a document sent by mail is necessary. The NRC will also develop procedures for the partial redaction of social security numbers where feasible and will include instructions that social security numbers not be visible on the outside of any package sent by mail.

The following section is a list of documents sent by mail that were used by the NRC during the past year and included an individual's complete social security number. About 90 percent of the listed documents are government-wide forms. The NRC will coordinate with other Agencies, as appropriate, during the development of the regulations.
