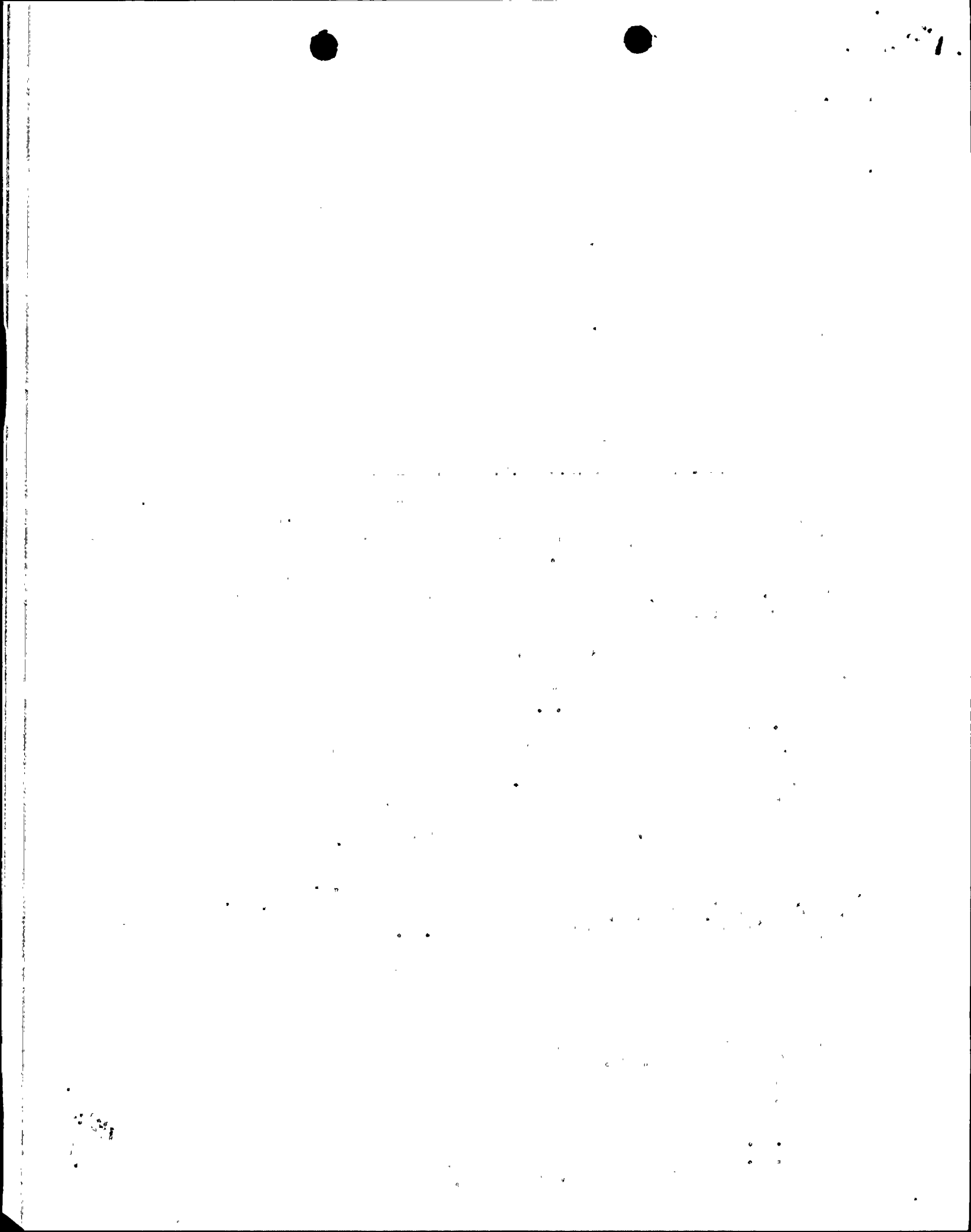

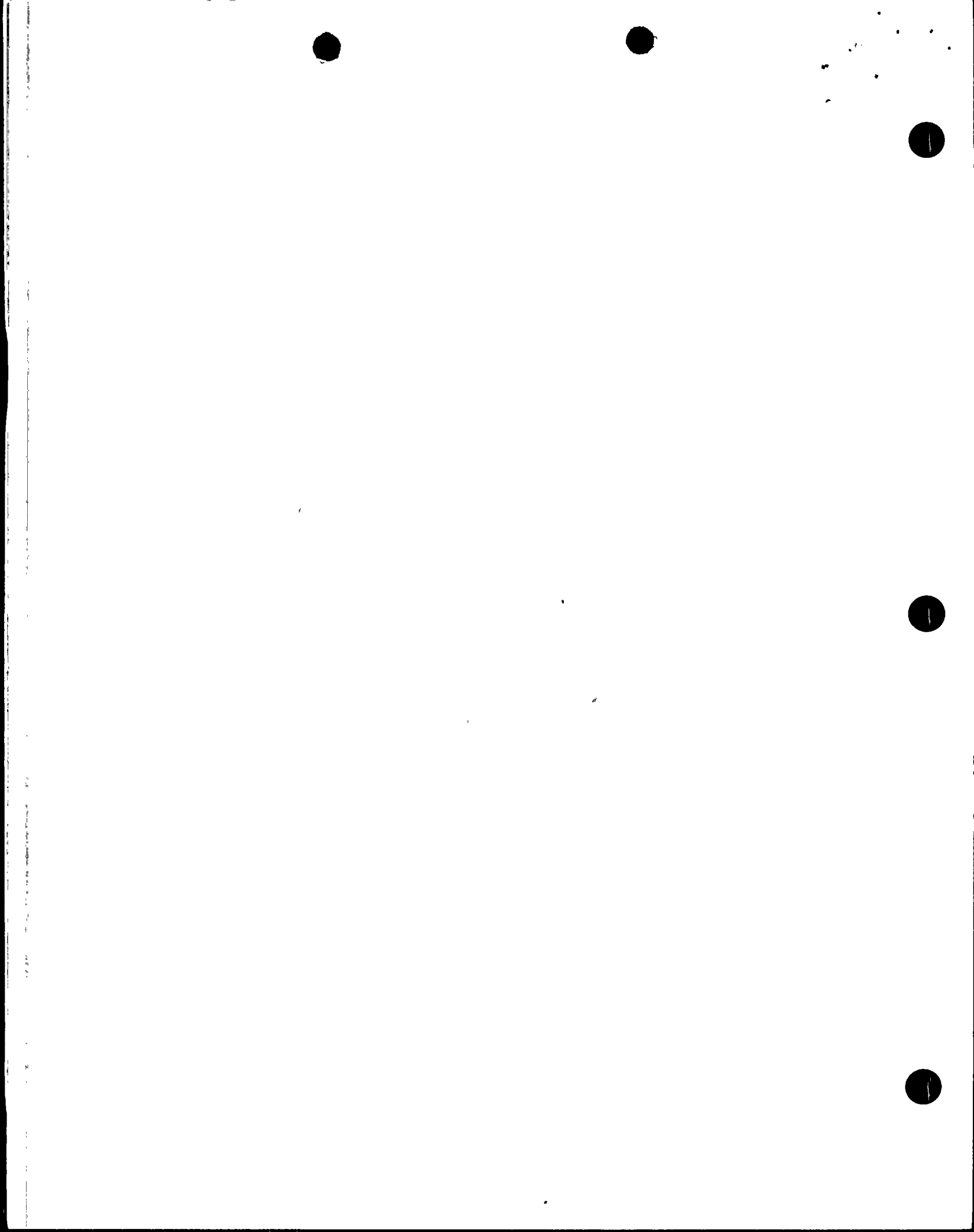

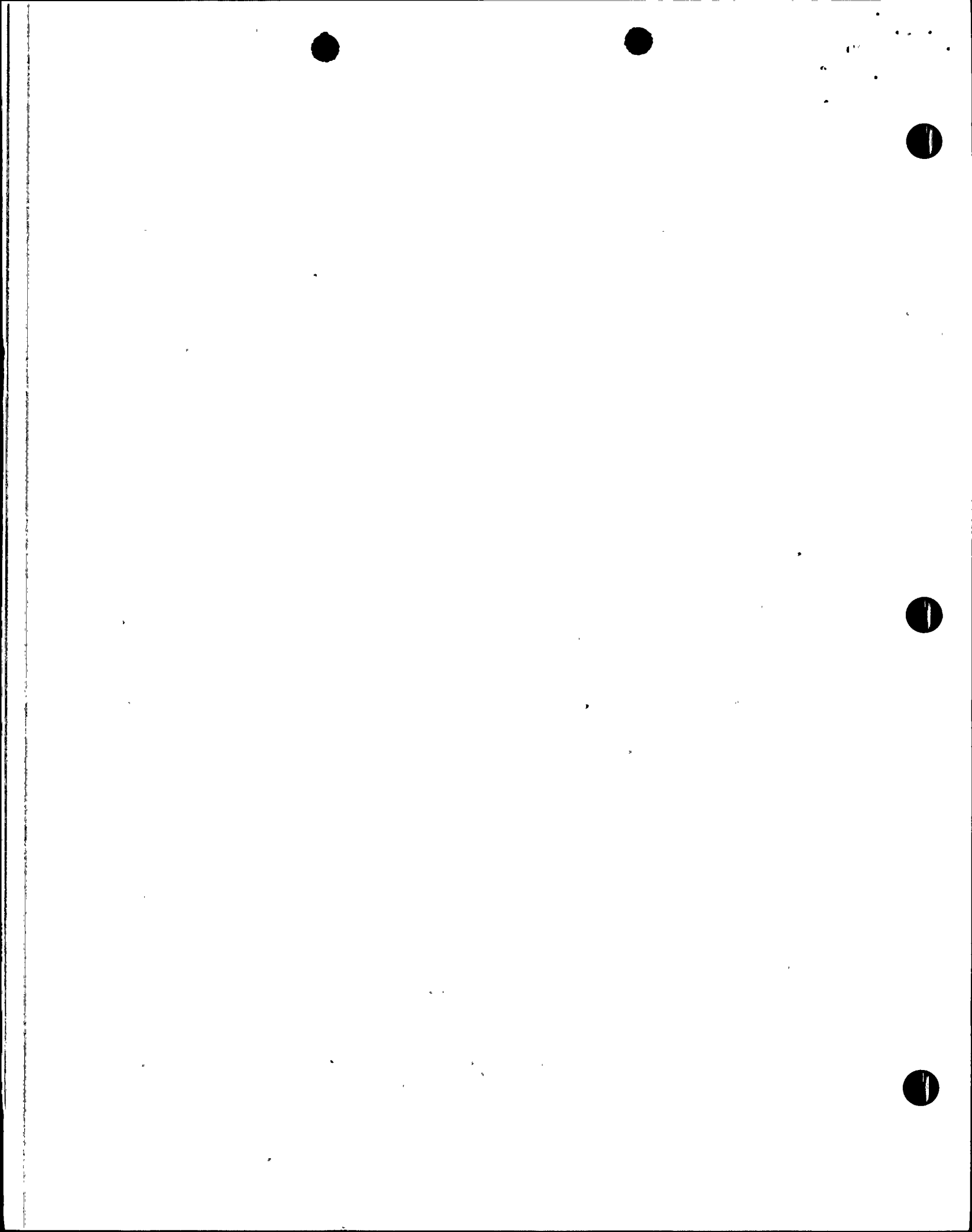

In the recent NRC Exit Interview on February 12, 1987, a potential violation was discussed regarding "Controlled-by-User" (CBU) information. This potential violation was based on the fact, CBU information was not accurately updated in a timely manner, by the appropriate CBU document holders.

In an effort to support project personnel, NRM has issued various CBU documents to provide readily-accessible documents at their work stations.

Various NRM project procedures govern the controlled-by-user document holders responsibilities regarding their CBU documents. These responsibilities, include:

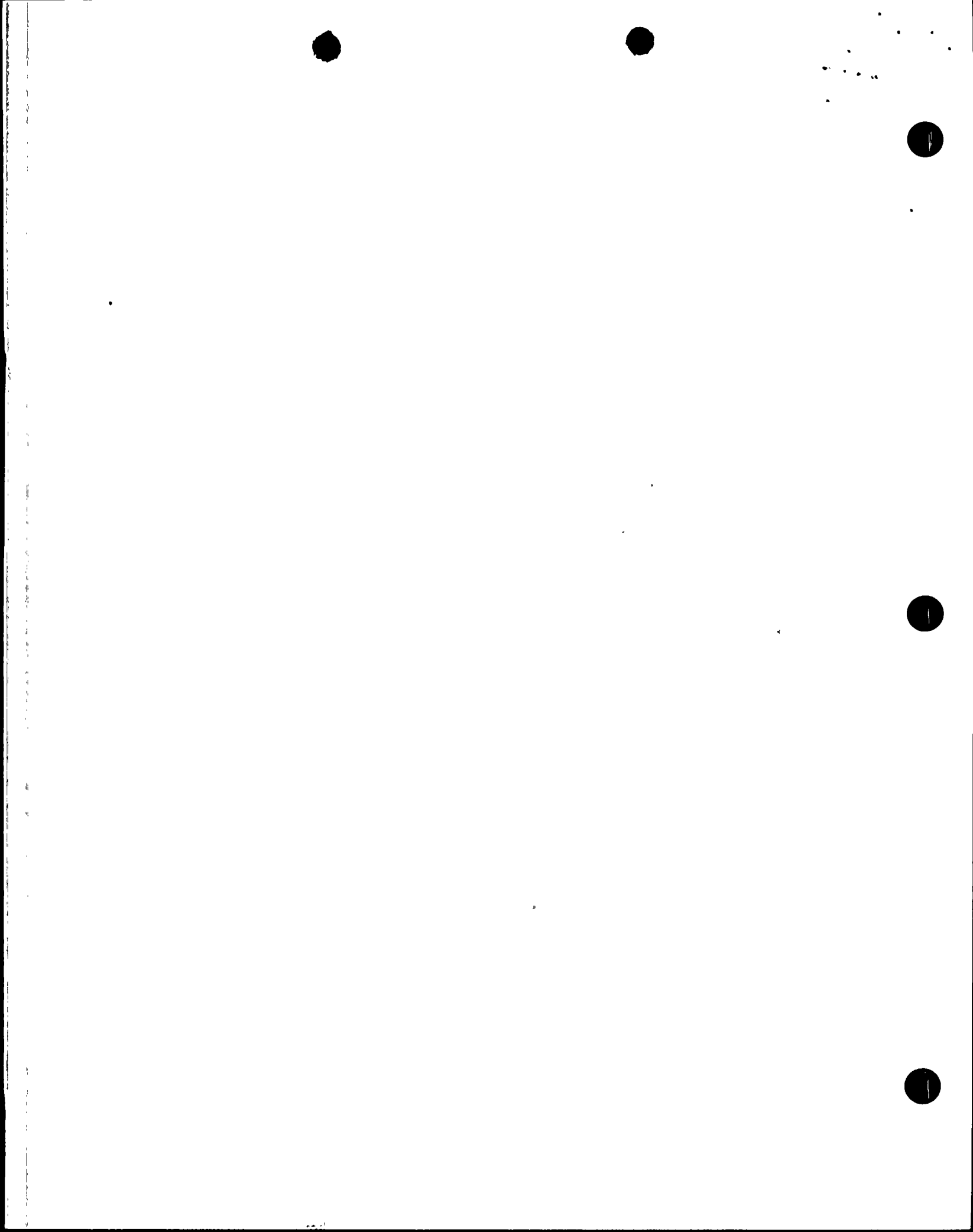
1. Verify the status of documents against an NRM controlled copy and/or appropriate computerized index, prior to use and daily during use.
2. Update the CBU documents in their possession in a timely manner, upon receipt from NRM.
3. Ensure destruction of out-dated CBU documents.
4. Perform periodic internal reviews to ensure accuracy of their CBU documents.

The procedures, which govern these responsibilities, are: 78AC-OZZ01, 78AC-OZZ03, 78AC-OZZ04, 78AC-OZZ05, 78AC-OZZ09, 9N219.10.00, -9N219.11.00 and 9N219.14.00.

The NRC notified the project on February 27, 1987, this potential violation would be issued as a follow-up item instead of a violation. Due to this item of deficiency, please reinstruct personnel in your department of their responsibilities for "Controlled-by-User" Information.

Various NRM project procedures govern the controlled-by-user document holders responsibilities regarding their CBU documents. These responsibilities, include:

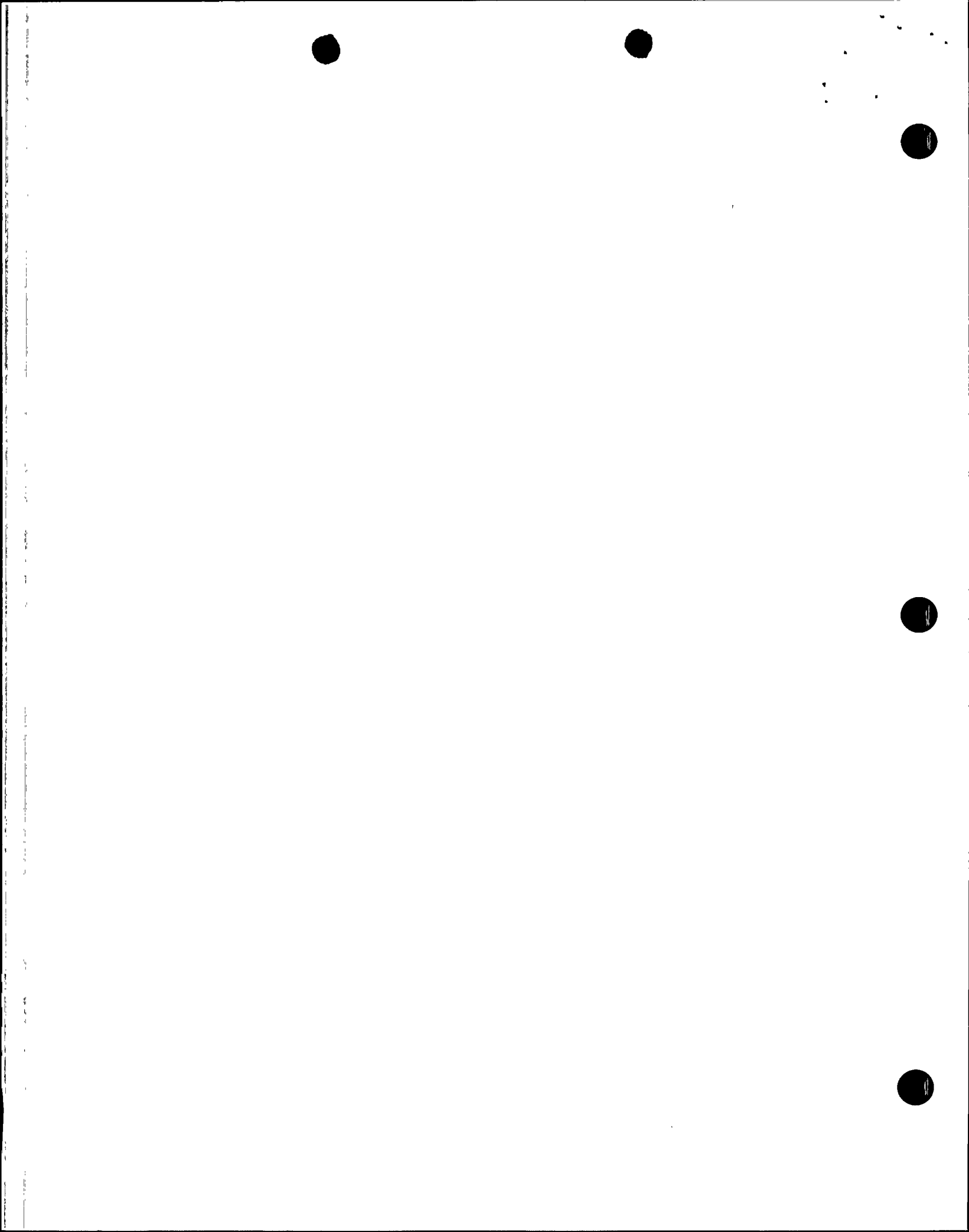
1. Verify the status of documents against an NRM controlled copy and/or appropriate computerized index, prior to use and daily during use.

The procedures, which govern these responsibilities, are: 78AC-OZZ01, 78AC-OZZ03, 78AC-OZZ04, 78AC-OZZ05, 78AC-OZZ09, 9N219.10.00, -9N219.11.00 and 9N219.14.00.

The NRC notified the project on February 27, 1987, this potential violation would be issued as a follow-up item instead of a violation. Due to this item of deficiency, please reinstruct personnel in your department of their responsibilities for "Controlled-by-User" Information.

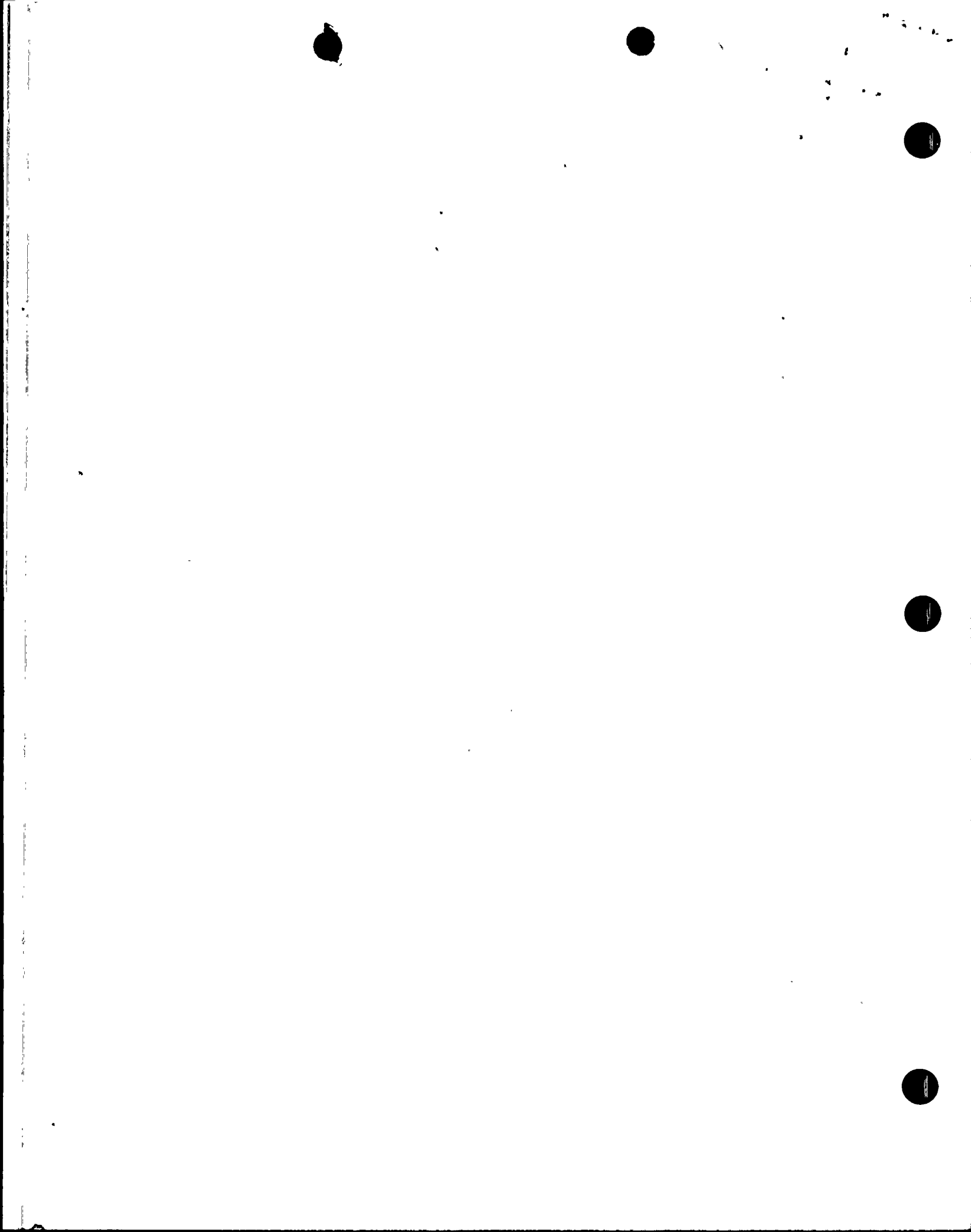

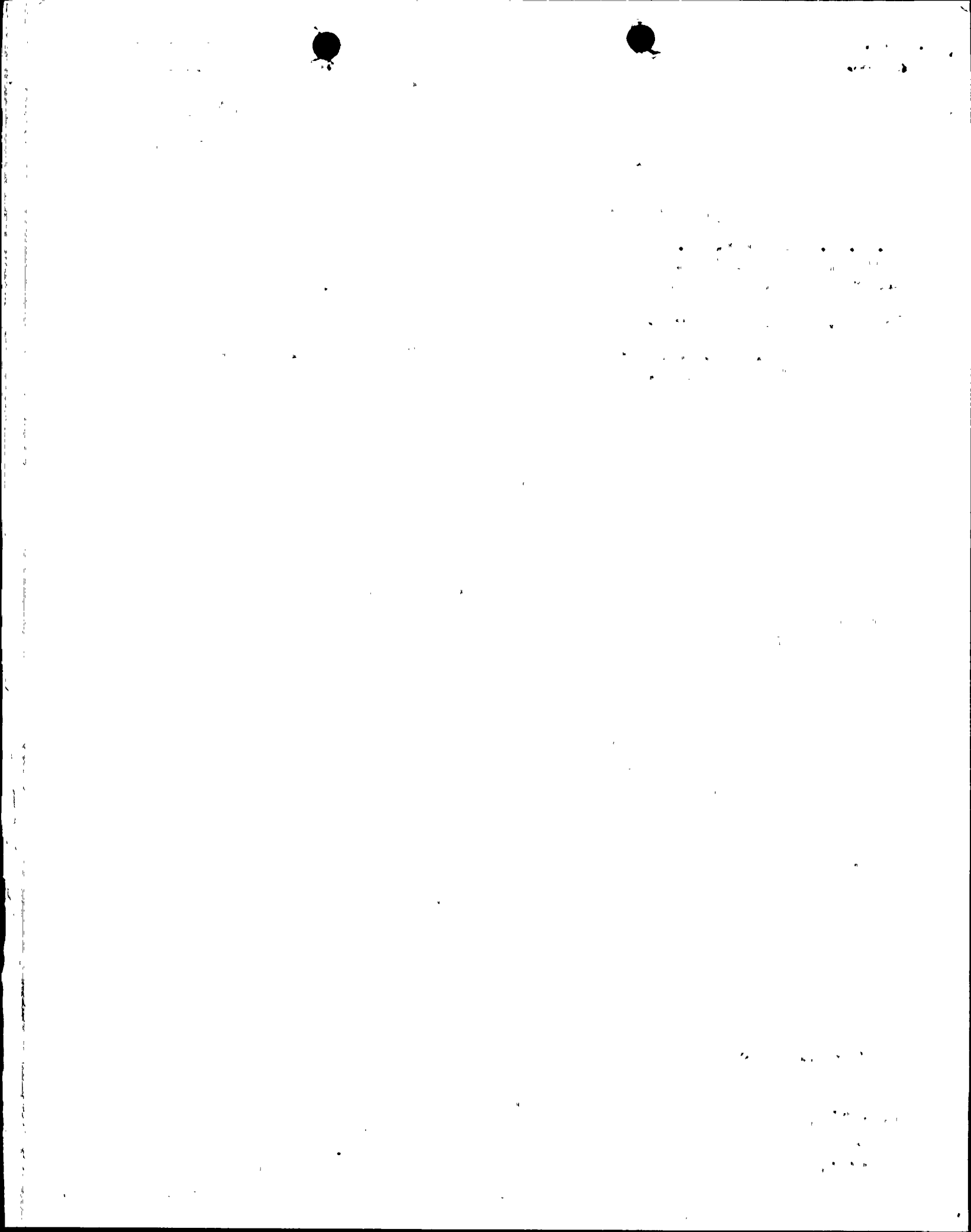

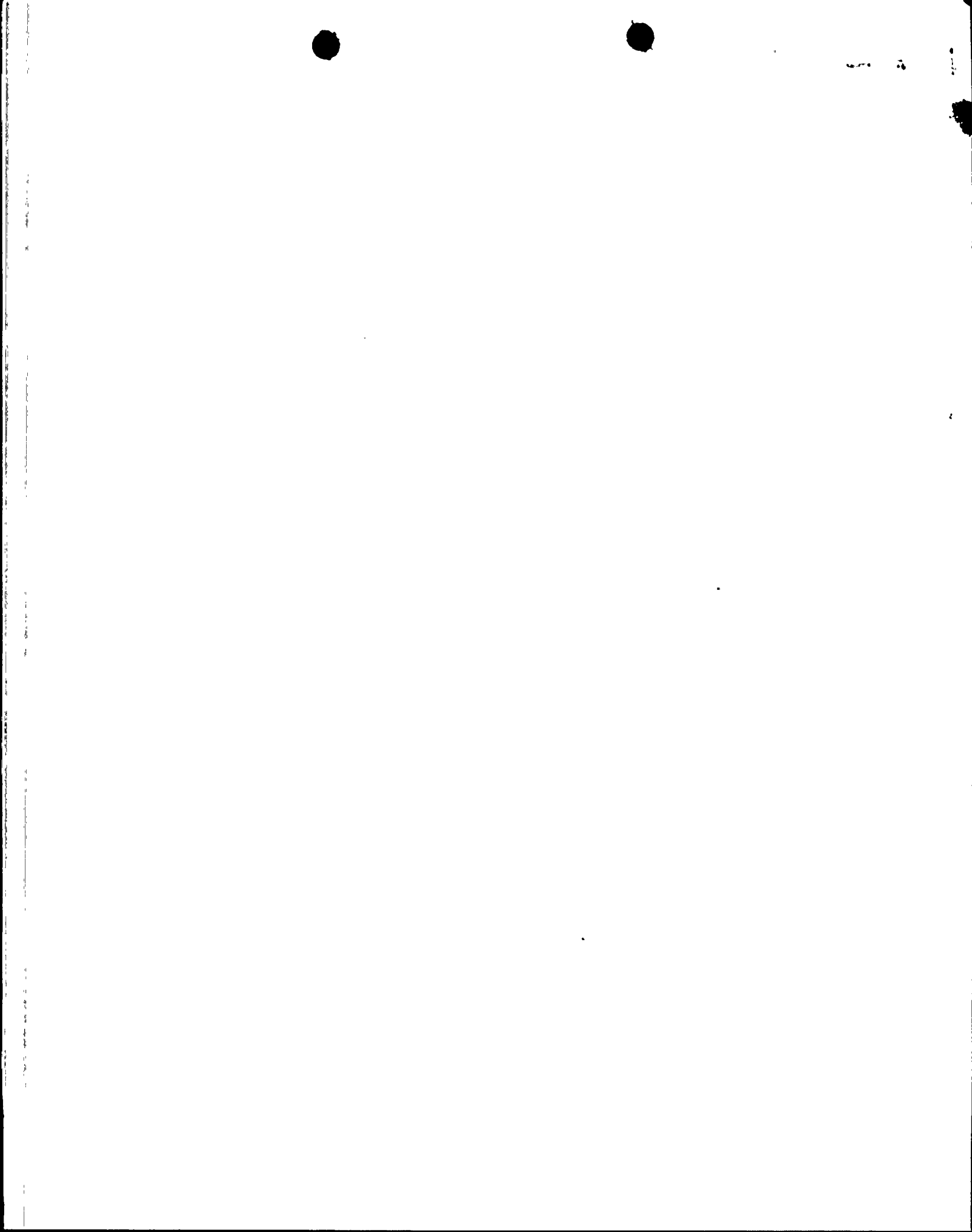
