In the referenced letter, APS responded to the bulletin and committed to remove or repair the tube plugs of the affected heat treat numbers during the Unit 2, Cycle 3 refueling outage. APS has removed the 95 Westinghouse Inconel 600 mechanical tube plugs that were identified in Table 1 of the referenced letter, and replaced them with Inconel 690 mechanical tube plugs during the Unit 2, Cycle 3 refueling outage.


