SUBJECT: REPORT OF MEETING WITH APS MANAGEMENT

This refers to the meeting held with Mr. J. Levine and other members of your staff at the Arizona Public Service Company corporate office in Phoenix, Arizona, on August 2, 1991. The subjects discussed are summarized in Meeting Report Nos. 50-528/91-32, 50-529/91-32, and 50-530/91-32, enclosed herewith. A copy of the slides used during your presentation is also enclosed.

During the meeting, we discussed the status of the units and current issues, on-line maintenance, various engineering issues, Unit 2 outage preparations, and the APS Five Year Business Plan and Diagnostic Evaluation Team action items. During the meeting, several issues were highlighted:

- o Performance appears to be improving overall, yet problems still occasionally occur.
- o You are improving operational and maintenance practices based on results of your probabilistic risk assessments.
- o You are increasing your expectations of personnel performance.
- o You remain committed to complete the resolution of significant issues identified by the NRC Diagnostic Evaluation Team.

We look forward to future discussions with you regarding your progress toward further improved performance.
