Please find enclosed Amendment Number 10 to NRC License Number 53-27731-01 approving the conducting of radiography outside of your field station address specified in Condition 10(i)(B), as requested. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(14)(vi). This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
