SUBJECT: Request for an expedited amendment of NRC License 19-00294-19, Docket No. 030-04523

1. U.S. Army Aberdeen Test Center (ATC) requests an expedited amendment to correct a typographical error in NRC License 19-00294-19:

a. Authorized use, currently reads: "G. and M. For use in Troxler 3400 series portable gauging devices for measuring physical properties of materials."

b. Request that Section 9. Authorized use, be corrected to read: "G. and L. For use in Troxler 3400 series portable gauging devices for measuring physical properties of materials."

c. This expedited request is necessary in order to purchase four additional Troxler gauges that are used to support Combat Vehicle testing at ATC. This Congressionally-mandated testing assess vehicle performance against explosive threats and is required prior to use by Soldiers in the field. Without these gauges, this critical testing will be delayed. Troxler Electronic Laboratories will not allow the purchase of the gauges until the above error is resolved.
