In accordance with 10 CFR 50.90, Florida Power & Light Company (FPL) submits herewith a request to amend Facility Operating License DPR-67.

As required by 10 CFR 50.55a(g), FPL updated the Inservice Inspection Program (ISI) for St. Lucie Unit I to the requirements of the 1974 Edition through Summer 1975 Addenda of Section XI of the ASME Boiler and Pressure Vessel Code. This is still applicable for the first 10 year Inspection Interval which ends February 11, 1988. As a result of this update, proposed Technical Specifications were submitted to NRC by FPL letters L-77-203, dated July 1, 1977, and L-77-291, dated September 16, 1977. Also, on September 8, 1978, FPL letter L-78-295 was submitted to incorporate revisions to the program based on meetings between FPL and NRC staff in May 1978. Interim NRC approval of the FPL program was granted on December 20, 1977, however, final NRC approval is still pending.

Due to the length of time which has expired since the original ISI and Inservice Testing (IST) Technical Specification proposals, and based on conversations between FPL and the NRC, revised Technical Specification submittals are being developed by FPL for both the ISI and IST programs. The revised submittals will replace those submittals which were proposed in 1977 and 1978.

The subject proposed amendment involves changes to Technical Specification 3.4.10, RCS - Structural Integrity ASME Code Class 1, 2 and 3 Components. Also, included is a change to the St. Lucie Unit I Technical Specifications, Section 4.0, Surveillance Requirements.

A marked up copy of the affected Technical Specification pages is included as Attachment 1. An Evaluation in support of the proposed amendment is included in Attachment 2. A "Determination of No Significant Hazards Consideration" is provided as Attachment 3.

The proposed amendment has been reviewed by the St. Lucie Facility Review Group and the Florida Power & Light Company Nuclear Review Board.


In accordance with 10 CFR 50.91(b)(1), a copy of the proposed amendment is being forwarded to the state designee for the State of Florida.




