The purpose of this letter is to announce an integrated assessment team inspection at your Palo Verde Nuclear Power Station. We have scheduled this inspection for the period of September 26 through October 7, 1994.

The inspection objective will be to perform an integrated assessment of your performance with a focus of evaluating the effectiveness of your identification and resolution of performance issues in engineering and maintenance. The inspection will be conducted using Inspection Procedure 40500, "Effectiveness of Licensee Controls in Identifying, Resolving, and Preventing Problems," and other NRC inspection procedures. The inspection team will consist of the team leader and three inspectors.

To assist the team in its evaluation of your ability to identify and resolve problems, we request that you provide to the Region IV office a summary of the self-assessment activities that you have performed since May 1993 and the results by September 12, 1994.
