GE HITACHI GLOBAL LASER ENRICHMENT, LLC REQUEST TO USE TRUSTED DOWNLOAD

As Authorizing Official (AO) for GE Hitachi Global Laser Enrichment (GLE) classified computer networks, the Department of Energy (DOE) Nuclear Energy Oak Ridge Site Office (NE-ORSO) has reviewed GLE's request in the enclosed letter for approval to use Trusted Download as a tool in its classified program. In reviewing the two options presented by GLE in this letter, DOE NE-ORSO has determined that Option A is the better option. Option A allows the use of the trusted download process as identified in GLEP-00062-R, "Trusted Download Process Plan for GE Hitachi Global Laser Enrichment." GLEP-00062-R was submitted to the Nuclear Regulatory Commission as a draft document on June 2, 2014. However, DOE NE-ORSO's approval as AO of Option A is subject to the fulfillment of the conditions in the following paragraph.

Prior to implementation of the Trusted Download process as described in GLEP-00062-R, GLE must issue the final approved version of this document. Upon issuance of this final approved document, GLE must revise GLEP-00015-R, *Program Cyber Security Plan – Engineering and Industrial Control System Environments for the GE Hitachi Global Laser Enrichment LLC Wilmington, NC Facilities*, to reference GLEP-00062-R. Upon approval and issuance of these documents, DOE NE-ORSO, as AO, authorizes GLE to use the Trusted Download process as identified in GLEP-00062-R in performing Trusted Downloads of information for the classified network identified in GLEP-00015-R.
