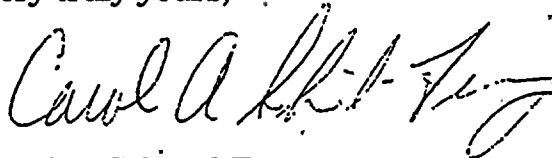

NOTICE OF FILING APPLICATION

On February 29, 1996, in compliance with the CPUC's recent decision to change the way electric utilities are regulated, Southern California Edison Company (Edison) filed a proposal with the California Public Utilities Commission (CPUC). Edison requested a new rate mechanism for its 15.8% share of Palo Verde Nuclear Generating Station Unit Nos. 1, 2, and 3 (Palo Verde).

The proposed rate mechanism for Palo Verde will:

- Increase Edison's Palo Verde revenue requirement by \$85 million, beginning January 1, 1997. We are proposing to offset this increase with several nuclear-related revenue requirement decreases in other CPUC proceedings. As stated in our application, this request is consistent with Edison's goal to achieve a system average rate below 10 cents per kWh by the year 2000, a decrease of 25% after adjusting for inflation;
- Assure that customers pay certain future Palo Verde operating costs only for power actually received on a pre-set cents per kilowatthour basis, and only if the plants operate; and

• Allow the costs of Edison's existing Palo Verde investment to be recovered over a seven year period ending in 2003, instead of a 14-year period ending in 2010, at a rate of return of 7.34% (approximately 2.2% lower than Edison's presently authorized rate of return on rate base), resulting in customer savings of \$787 million in nominal dollars (or \$93 million in net present value) over the remaining life of the units.

HOW THE PROPOSAL MIGHT AFFECT CUSTOMER RATES

If our request is approved, the resulting rate change for each customer class will be determined in future proceedings. The potential rate changes cannot be predicted exactly because they depend on future performance of Palo Verde. If allocated by the CPUC on an equal percentage basis, Edison's Palo Verde revenue requirement, developed using a reasonable forecast of Palo Verde performance (77% Capacity Factor), would result in the following rate changes:

As previously mentioned, we are proposing to offset the rate increase associated with this request with several nuclear-related revenue requirement decreases in other CPUC proceedings. In no case under Edison's proposal will there be a rate increase over current rates due to this proposal. Should revenue requirements during any year exceed the adopted amounts currently reflected in rates, such amounts will be deferred to a subsequent year for rate recovery purposes. If allocated by the CPUC on an equal percentage basis, rate changes for Edison's nuclear-related revenue request, developed using a reasonable forecast of Palo Verde (77% Capacity Factor) and SONGS 2&3 (78% Capacity Factor) performance, are as follows:

Edison expects the CPUC to conduct evidentiary hearings on our request. If hearings are held, Edison representatives, interested parties, and the CPUC's Division of Ratepayer Advocates (DRA) may present testimony. The DRA employs engineers, accountants, economists, attorneys, and other professionals who independently evaluate utility rate change proposals and present their analyses and recommendations to the CPUC.

The CPUC can accept, reject, or modify the recommendations of any of the parties.

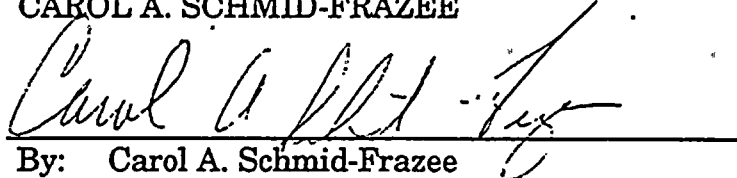
